
HOUSE RESOLUTION

AUTHORIZING AND EMPOWERING THE SPEAKER TO PERFORM AND CARRY OUT
ANY OFFICIAL LEGISLATIVE BUSINESS DURING THE INTERIM
BETWEEN THE 2023 AND 2024 REGULAR SESSIONS.

1 BE IT RESOLVED by the House of Representatives of the
2 Thirty-second Legislature of the State of Hawaii, Regular
3 Session of 2023, that the Speaker be, and is hereby authorized
4 and empowered during the interim between the 2023 and 2024
5 Regular Sessions, to:

6
7 (1) Expend such sum or sums from the funds appropriated
8 for legislative and other expenses of the Thirty-
9 second Legislature, Regular Session of 2023;

10
11 (2) Contract, hire, or employ personnel and assistance,
12 including:

13
14 (A) Designating which of the employees and officers
15 of the House shall be given additional employment
16 to meet the after-session work demands; and

17
18 (B) Approving the employment of individuals prior to
19 the convening of the Regular Session of 2024;

20
21 and the period of employment for each;

22
23 (3) Establish and approve any action of standing, interim,
24 select, investigative, and special committees,
25 including:

26
27 (A) Authorizing meetings to obtain information and
28 conduct hearings;

29
30 (B) Determining members, functions, and duties of
31 such committees; provided that the Speaker,



1 notwithstanding any prior authorization or
2 action, may, at the Speaker's discretion, limit
3 the number of members of the House participating
4 on the committee;

5
6 (C) Issuing subpoenas as provided by law or rules of
7 the House;

8
9 (D) Authorizing in writing the payment of any
10 committee related expenditure prior to the
11 payment being made or incurred; and

12
13 (E) Implementing a requirement that a full report of
14 all activities of the committees, including their
15 respective findings and recommendations, shall be
16 made periodically to the Speaker as the Speaker
17 so desires, and to the Legislature within ten
18 days after the convening of the Regular Session
19 of 2024; and

20
21 (4) Approve the Journal of the House of any legislative
22 day being compiled as of the 60th session day,

23
24 all for the purposes of completing the work of the Thirty-second
25 Legislature, Regular Session of 2023, subsequent to the
26 adjournment thereof, including the carrying out of any official
27 legislative business in the interim between the 2023 and 2024
28 sessions, up to and including January 17, 2024, this
29 authorization being in addition to any other authorization
30 heretofore granted to the Speaker or any other officer or
31 officers of the House of Representatives.
