A BILL FOR AN ACT

RELATING TO THE OFFICE OF HAWAIIAN AFFAIRS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to clarify the 2 purpose of the working group established by Act 226, Session Laws of Hawaii 2022, by specifying that the working group shall 3 4 be a temporary public land trust working group and will be 5 placed within the office of the governor for administrative 6 purposes only. The working group shall have the sole, special 7 purpose of compiling a definitive inventory of the lands that 8 comprise the public land trust described in section 4, and 9 referred to in section 6, of article XII of the state 10 constitution. The legislature intends that this inventory will 11 be the basis for future legislation to determine the income and 12 proceeds from the pro rata portion of the public land trust under article XII, section 6, of the state constitution for 13 14 expenditure by the office of Hawaiian affairs for the betterment 15 of the conditions of native Hawaiians.

16 SECTION 2. Act 226, Session Laws of Hawaii 2022, is 17 amended by amending section 3 to read as follows:

2	working group with a comprehensive list of all parcels of land
3	that the office of Hawaiian affairs believes:
4	(1) Are required to be included in the public land trust
5	inventory; and
6	(2) Constitute crown lands that should be included in the
7	public land trust inventory.
8	(e) The members of the working group shall appoint,
9	without regard to chapters 76 and 89, Hawaii Revised Statutes,
10	an executive director who shall serve at the pleasure of the
11	working group. The executive director shall oversee the day-to-
12	day operations of the working group and perform other functions
13	as directed by the working group, including procuring any
14	professional and other services necessary to complete the
15	inventory of the public land trust. The executive director's
16	salary shall be determined by the working group.
17	(f) The working group may employ, without regard to
18	chapters 76 and 89, Hawaii Revised Statutes, and at its pleasure
19	dismiss, other persons whom the working group deems necessary
20	for the performance of its functions. The working group may fix

1 the compensation of any persons employed pursuant to this 2 subsection. (g) The working group shall submit an annual report on the 3 4 progress of its work to the legislature no later than twenty days prior to the convening of each regular session. The 5 working group shall further submit interim progress reports to 6 7 the legislature, office of Hawaiian affairs, and governor by the 8 close of each fiscal quarter." 9 SECTION 3. There is appropriated out of the general 10 revenues of the State of Hawaii the sum of \$ or so 11 much thereof as may be necessary for fiscal year 2023-2024 and the same sum or so much thereof as may be necessary for fiscal 12 13 year 2024-2025 to carry out the purposes of this Act, including 14 the hiring of necessary staff, purchasing of equipment, and 15 procurement of professional and other services. 16 The sums appropriated shall be expended by the office of 17 the governor for the purposes of this Act. 18 SECTION 4. Statutory material to be repealed is bracketed 19 and stricken. New statutory material is underscored.
