A BILL FOR AN ACT

RELATING TO EDUCATIONAL HEALTH SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. All medication requests to be administered by 2 school health assistants are currently reviewed and must be 3 approved by Hawaii department of health public health nurses. 4 This process ensures that a health care professional has 5 reviewed the medication request and determined that it is safe 6 and appropriate for a student to receive treatment. For 7 example, some medications would be best administered before or 8 after school and other medications may not be allowed if a 9 school health assistant is not qualified to assess the need for 10 as-needed medication. Medication administration is part of the 11 medication management process and requires clinical supervision 12 by a health care professional, including a registered nurse, 13 advanced practice registered nurse, physician assistant, or 14 physician, to ensure the health and safety of students if 15 unlicensed assistive personnel, such as school health 16 assistants, are utilized.

Some schools have a registered nurse, advanced practiceregistered nurse, or other specialized health care provider on

1 campus through written agreements with the department of 2 education. Partnerships with federally gualified health centers 3 and the University of Hawaii at Manoa school of nursing have 4 greatly improved access to health services for students at 5 school and through telehealth. Student care would be more 6 efficient, accessible, and safe if the administration of the 7 medication could be performed with the approval of a health care 8 professional within the department of education, department of 9 health, or a health care service per a written agreement with 10 the department of education. The current law prevents health 11 care professionals who are already on campus or in the school 12 community from performing the function of medication approval.

13 The purpose of this Act is to allow administration of 14 medications by school health assistants at school with the 15 approval of a health care professional within the department of 16 education, department of health, or health care service per a 17 written agreement with the department of education. This Act 18 amends statutes to match the existing department of education 19 practice for administration of medication at schools. This Act 20 also updates the term "school health aides" to "school health 21 assistants" to reflect updated job titles at the department of 22 education.

SECTION 2. Section 302A-708, Hawaii Revised Statutes, is
 amended to read as follows:

3 "[4]\$302A-708 Career development opportunities.[4] The
4 department of education shall provide career pathways
5 development and training opportunities to all school health
6 [aides] assistants in the school health services field and other
7 fields within the department of education to ensure the
8 opportunity for continued employment with the department of
9 education."

10 SECTION 3. Section 302A-853, Hawaii Revised Statutes, is
11 amended to read as follows:

12 "§302A-853 Administration of medication. (a) School 13 health [aides] assistants may assist students by administering 14 oral and topical medication, and in emergency situations, other 15 premeasured medication; provided that:

16 (1) If the student receiving the medication is a minor, a
17 parent or guardian requests and authorizes the
18 administration of medication;

19 (2) The medication has been prescribed by a licensed
 20 physician, as defined in section 334-1, or by a
 21 practitioner with prescriptive authority;

DEPARTMENT: Education

TITLE: A BILL FOR AN ACT RELATING TO EDUCATIONAL HEALTH SERVICES.

- PURPOSE: Allows the administration of medication to public school students by health assistants with the approval of a health care professional within the Department of Education, Department of Health, or a health care service per a written agreement with the Department of Education. Replaces the term "school health aides" with "school health assistants" to reflect recent changes to the job title.
- MEANS: Amends sections 302A-708, 302A-853, 302A-854, and 457-13, Hawaii Revised Statutes.
- Under current law, all medication requests JUSTIFICATION: to be administered by school health assistants are currently reviewed and must be approved by Hawaii Department of Health public health nurses. This process ensures that a health care professional has reviewed the medication request and determined that it is safe and appropriate for a student to receive treatment. For example, some medications would be best administered before or after school and other medications may not be allowed if a school health assistant is not qualified to assess the need for as-needed medication. Medication administration is part of the medication management process and requires clinical supervision by a health care professional, including a registered nurse, advanced practice registered nurse, physician assistant, or physician, to ensure the health and safety of students if unlicensed assistive personnel, such as school health assistants, are utilized.
