A BILL FOR AN ACT

RELATING TO LICENSES TO SOLEMNIZE MARRIAGES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that Act 211, Session 1 Laws of Hawaii 2021 (Act 211), authorized the issuance of a 2 civil license to solemnize marriages. Prior to enactment, only 3 4 individuals with religious affiliations or judicial appointments 5 could obtain a license to solemnize marriages. 6 Act 211 also established fees for a civil license to 7 solemnize marriages, the intent of which was to enhance general 8 revenues from approximately twenty thousand marriages per year, two-thirds of which are for out-of-state and international 9

10 couples. However, there are no fees for religious and judicial

11 licenses to solemnize marriages.

13 (1) Establish standard and short-term licenses and license
