A BILL FOR AN ACT

RELATING TO MENTAL HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I

2 SECTION 1. The legislature finds that the State has repeatedly and consistently been recognized by the federal 3 government as a health professional shortage area, meaning the 4 5 State sorely lacks a sufficient number of mental health professionals, including psychiatrists, psychologists, social 6 7 workers, marriage and family therapists, and mental health 8 counselors having a focus on marriage and family life, to meet 9 the overwhelming demand for these services in the State. These 10 barriers to access create unnecessarily long wait times for 11 appointments, causing many individuals, especially those 12 individuals living in rural areas, to experience prolonged suffering or to choose not to seek any help at all. The result 13 is a domino effect of mass losses in work force development, 14 increased instances of abuse within families, statistically 15 higher rates of substance abuse, and high debt loads. 16

1 Currently, associate-level practitioners who have completed 2 rigorous educational and other professional development 3 requirements are deemed capable of rendering professional 4 services to clients seeking mental health treatment under 5 licensed clinical supervision in order to complete the 6 post-degree, pre-license hours required for full licensure status. However, unlike many other professions and trades that 7 8 have similar requirements, because no laws exist to allow for 9 health insurance reimbursements of their services, almost all of 10 these mental health professionals go unpaid for the lifechanging 11 services that the professionals perform for residents of the 12 State.

13 This regulatory oversight causes undue hardships on these 14 individuals and their families as they are essentially forced to 15 work one very difficult and taxing job for free and a second job 16 to meet personal needs. Unfortunately, this model of living is 17 unsustainable and causes too much homegrown talent to 18 permanently move to one of the many other states in which 19 insurance reimbursements are allowed.

20 Accordingly, the purpose of this Act is to expand access to21 high quality mental health services by:
