### A BILL FOR AN ACT

RELATING TO CULTURE AND ARTS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the aloha order of
 merit was established to recognize national or international
 achievement in a field either by a single event or by the
 totality of work that has either been pioneering in that field
 or that has been outstanding in the long term.

6 Accordingly, the purpose of this Act is to establish the 7 Hawaii leadership award program to honor individuals who have 8 made considerable and outstanding contributions to Hawaii and 9 serve as inspirations to others.

SECTION 2. Chapter 9, Hawaii Revised Statutes, is amended by adding a new section to part I to be appropriately designated and to read as follows:

13 "<u>§9-</u> Hawaii leadership award program. (a) There is
14 established within the foundation for administrative purposes
15 the Hawaii leadership award program to honor individuals who:
16 (1) Have made considerable and outstanding contributions
17 to Hawaii; and

- 1 (2) Serve as inspirations to others. 2 Awards shall be presented to individuals in each of (b) 3 the following categories: 4 (1) Arts; (2) Business and labor; 5 6 (3) Entertainment 7 (4) Food and drink; 8 (5) Literature; 9 (6) Music; 10 (7) Public service; 11 (8) Science; 12 (9) Sports; 13 (10) Community engagement; 14 (11) Profile in courage; and 15 (12) Friend of Hawaii, 16 who have resided in the State for a period of at least seven 17 years, except that no individual receiving an award pursuant to 18 paragraph (12) shall reside in the State. 19 (C) The governor and members of the Hawaii leadership 20 award selection committee shall present the awards annually.
- 21 (d) Each awardee shall:



1	(1)	Receive a certificate of honor and medal;
2	(2)	Have the awardee's story and a statement of
3		recognition displayed in a conspicuous place for a
4		period of one year; and
5	(3)	Have the awardee's name added to a permanent archive
6		of awardee names.
7	<u>(e)</u>	Awardees shall be selected by a Hawaii leadership
8	award sel	ection committee. The selection committee shall
9	comprise	the following members, or their designees:
10	(1)	The lieutenant governor;
11	(2)	The chairperson of the house of representatives
12		standing committee having jurisdiction over culture
13		and arts; and
14	(3)	The chairperson of the senate standing committee
15		having jurisdiction over culture and arts.
16	<u>(f)</u>	Nominations for awardees shall be accepted by the
17	<u>Hawaii le</u>	adership award selection committee from the public."
18	SECT	ION 3. There is appropriated out of the general
19	revenues	of the State of Hawaii the sum of \$150,000 or so much
20	thereof a	s may be necessary for fiscal year 2023-2024 and the

same sum or so much thereof as may be necessary for fiscal year
 2024-2025 to establish the Hawaii leadership award program.
 The sums appropriated shall be expended by the state
 foundation on culture and the arts for the purposes of this Act.
 SECTION 4. New statutory material is underscored.
 SECTION 5. This Act shall take effect on July 1, 2023.
