A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that as fuel tax revenues 2 decrease, the department of transportation recommends the adoption of a per-mile road usage charge system to provide 3 4 sustainable funding for the State's road infrastructure. The 5 legislature also finds that with its existing vehicle inspection 6 program, Hawaii is well-positioned to transition to a per-mile 7 road usage charge system at low administrative costs. The 8 legislature additionally finds that replacing the registration 9 surcharge on electric vehicles with a mileage-based road user 10 fee is a minimally disruptive first step to transition the State 11 to: a per-mile road usage charge system as recommended by the 12 department of transportation. With the increase in public 13 support for fuel-efficient electric and alternative fuel 14 vehicles, the shift to fees based on vehicle miles traveled is 15 fair to all drivers within the State and ensures that the owners 16 of alternative fuel vehicles pay a fair share of Hawaii's 17 roadway maintenance costs.

1 The legislature further finds that it is important to not 2 incentivize the department of transportation to increase overall 3 commuting and vehicle miles traveled to boost revenues from road 4 usage fees, which would increase cost and reduce quality of life 5 for residents. Therefore, a concerted strategy must be 6 developed and implemented to enable commuters to reduce overall 7 vehicle miles traveled and provide commuters who do not drive 8 themselves more affordable options such as efficient public transit, electric mobility, bicycling, and walking, which will 9 10 improve outcomes and reduce the number of cars on the road, 11 traffic, and costs. 12 Therefore, the purpose of this Act is to: 13 Ensure fairness for everyone using public roads, and (1) 14 sufficient revenues to maintain them, by replacing the 15 \$50 annual fee for electric vehicles with a mileage-16 based road user fee; and Ensure a lower cost of transportation for all 17 (2) 18 residents by amending the composition of the state 19 highway safety council and renaming it as the Hawaii 20 highway safety council to establish strategies,



1 metrics, and benchmarks to reduce vehicle miles 2 traveled and the cost of transportation. 3 SECTION 2. Chapter 249, Hawaii Revised Statutes, is 4 amended by adding a new section to be appropriately designated 5 and to read as follows: 6 "<u>§249-</u> State mileage-based road user fee. (a) All 7 electric vehicles in the State, except for vehicles that qualify 8 for any of the exemptions in sections 249-4, 249-5.5, 249-6, and 9 249-6.5, in addition to all other fees and taxes levied by this 10 chapter, shall be subject to an annual state mileage-based road 11 user fee. The fee shall be levied by the county director of 12 finance at the rate of cents per mile traveled during the 13 year, based on a comparison of the electric vehicle's current 14 odometer reading with the odometer reading of the previous year, 15 as noted on the electric vehicle's certificate of inspection 16 pursuant to section 286-26(e). The fee shall be capped at the 17 amount that the average non-electric vehicle in the State paid 18 in fuel tax for the previous year. 19 (b) The fee shall be paid each year together with all 20 other taxes and fees levied by this chapter on a staggered basis 21 as established by each county pursuant to section 286-51, and

1	the state mileage-based road user fee shall also be staggered so
2	that the state mileage-based road user fee is due and payable at
3	the same time and shall be collected together with the county
4	registration fee. The state mileage-based road user fee shall
5	be deemed delinquent if not paid with the county registration
6	fee. The respective counties shall collect this fee together
7	with the vehicle registration tax collected for the county and
8	shall transfer the moneys collected under this section to the
9	state director of finance for deposit into the state highway
10	fund established under section 248-8.
11	(c) For the purposes of this section, "electric vehicle"
12	means a vehicle, with four or more wheels, that draws propulsion
13	energy from a battery with at least four kilowatt hours of
14	energy storage capacity that can be recharged from an external
15	source of electricity."
16	SECTION 3. Chapter 286, Hawaii Revised Statutes, is
17	amended by adding a new section to be appropriately designated
18	and to read as follows:
19	"§286- Hawaii highway safety and modernization council.
20	(a) There is established the Hawaii highway safety and
21	modernization council. The council shall be placed in the

17		projects, decisions, and spending related to ground
18		transportation in the department of transportation,

1 SECTION 4. Section 249-31, Hawaii Revised Statutes, is 2 amended by amending subsection (a) to read as follows: 3 All vehicles and motor vehicles in the State as "(a) defined in section 249-1, including antique motor vehicles, 4 5 except as otherwise provided in sections 249-4, 249-6, and 6 249-31.5, shall be subject to a \$46 annual vehicle registration 7 fee; provided that [electric vehicles and] alternative fuel 8 vehicles shall pay an annual vehicle registration surcharge fee 9 of \$50, which shall be assessed and collected beginning with the first registration renewal for every [electric vehicle and] 10 alternative fuel vehicle and shall be deposited into the state 11 highway fund established under section 248-8. The fee shall be 12 13 paid each year together with all other taxes and fees levied by 14 this chapter on a staggered basis as established by each county as authorized by section 286-51, and the state registration for 15 that county shall likewise be staggered so that the state 16 17 registration fee is due and payable at the same time and shall be collected together with the county fee. The state 18 19 registration fee shall be deemed delinquent if not paid with the 20 county registration fee. The respective counties shall collect 21 this fee together with the vehicle registration tax collected

1 for the county and shall transfer the moneys collected under 2 this section to the State. 3 For the purposes of this subsection, "alternative fuel 4 vehicle" means a vehicle equipped to be powered by a non-5 petroleum-based fuel, but excludes an electric, electricity-6 recharged, or hybrid electric motor vehicle." 7 SECTION 5. Section 286-26, Hawaii Revised Statutes, is 8 amended by amending subsection (e) to read as follows: 9 "(e) Upon application for a certificate of inspection to 10 be issued for a vehicle or moped, an inspection as prescribed by 11 the director under subsection (g) shall be conducted on the 12 vehicle or moped, and if the vehicle or moped is found to be in 13 a safe operating condition, a certificate of inspection shall be 14 issued upon payment of a fee to be determined by the director. The certificate shall state the effective date, the termination 15 16 date, the name of the issuing insurance carrier, and the policy 17 number of the motor vehicle insurance identification card for 18 the inspected motor vehicle as specified by section 431:10C-107 19 or state the information contained in the proof of insurance 20 card as specified by section 431:10G-106. For an electric 21 vehicle, the certificate shall also state the odometer reading

1 of the vehicle on the date that the vehicle was inspected. A 2 sticker, authorized by the director, shall be affixed to the 3 vehicle or moped at the time a certificate of inspection is 4 issued. An inspection sticker which has been lost, stolen, or destroyed shall be replaced without reinspection by the 5 6 inspection station that issued the original inspection sticker 7 upon presentation of the current certificate of inspection; 8 provided that the current certificate of inspection and 9 inspection sticker shall not have expired at the time the 10 replacement is requested. The director shall adopt rules to 11 determine the fee for replacement of lost, stolen, or destroyed 12 inspection stickers. As used in this subsection, "electric vehicle" means a 13 14 vehicle that draws propulsion energy from a battery with at 15 least four kilowatt hours of energy storage capacity that can be 16 recharged from an external source of electricity." 17 SECTION 6. Section 286-41, Hawaii Revised Statutes, is 18 amended by amending subsection (b) to read as follows: 19 "(b) Application for the registration of a vehicle shall 20 be made upon the appropriate form furnished by the director of

finance and shall contain the name, occupation, and address of

1 the owner and legal owner; and, if the applicant is a member of 2 the United States naval or military forces, the applicant shall give the organization and station. All applications shall also 3 4 contain a description of the vehicle, including the name of the 5 maker; the type of fuel for the use of which it is adapted, such 6 as gasoline, diesel oil, liquefied petroleum gas[+], or 7 electricity; the serial or motor number; the date first sold by 8 the manufacturer or dealer; a further description of the vehicle 9 as is called for in the form; and other information as may be 10 required by the director of finance, to establish legal 11 ownership. A person applying for initial registration of a 12 neighborhood electric vehicle shall certify in writing that a 13 notice of the operational restrictions applying to the vehicle 14 as provided in section 291C-134 are contained on a permanent notice attached to or painted on the vehicle in a location that 15 16 is in clear view of the driver."

SECTION 7. Section 286-5, Hawaii Revised Statutes, isrepealed.

1	their designated representatives shall be members of the
2	council: the chief justice, the attorney general, the director
3	of health, the superintendent of education, the president of
4	the University of Hawaii, the chairperson of each of the county
5	highway safety councils established under section 286-6, and not
6	more than twenty other persons who shall be appointed by the
7	governor on the basis of their interest in highway safety.
8	The state highway safety council shall advise the governor
9	on matters relating to the programs and activities of the State
10	in the field of highway safety.
11	The members of the council shall serve without pay but
12	shall be entitled to reimbursement for necessary expenses while
13	attending meetings and while in discharge of their duties."]
14	SECTION 8. Statutory material to be repealed is bracketed
15	and stricken. New statutory material is underscored.
16	SECTION 9. This Act shall take effect on July 1, 2023;
17	provided that sections 2, 4, 5, and 6 of this Act shall take
18	effect on January 1, 2025.
