| 1 | SECTION 1. In accordance with section 9 of article VII of |
| 2 | the Hawaii State Constitution and sections 37-91 and 37-93, |
| 3 | Hawaii Revised Statutes, the legislature has determined that the |

- 8 The purpose of this Act is to establish an illegal
- 9 fireworks task force to plan, coordinate, and engage in law
- 10 enforcement operations to interdict illegal fireworks; develop a
- 11 comprehensive strategic plan to stop the importation of illegal
- 12 fireworks and explosives into Hawaii; promote compliance with
- 13 the state fireworks control laws; and ensure the safety and
- 14 security of the airports, harbors, and other facilities and
- 15 institutions in the State against the discharge of illegal
- 16 fireworks and explosives.
- 17 SECTION 3. (a) There shall be established within the
- 18 department of law enforcement for administrative purposes the
- 19 illegal fireworks task force. The task force shall use the
- 20 findings from the legislative reference bureau's 2019 report,
- 21 "Blast from the Past: An Update to the Report of the Illegal

- 1 Fireworks Task Force to the Legislature for the Regular Session
- 2 of 2011", as the basis for developing a comprehensive strategic
- 3 plan to stop the importation of illegal fireworks and explosives
- 4 into Hawaii; promote compliance with the state fireworks control
- 5 laws; and ensure the safety and security of the airports,
- 6 harbors, and other facilities and institutions in the State
- 7 against the discharge of illegal fireworks and explosives.
- 8 (b) The director of law enforcement or the director's
- 9 designee shall be the chair of the task force.
- 10 (c) The following individuals or their designees shall
- 11 serve as members of the task force:
- 12 (1) Attorney general;
- 13 (2) Deputy director of the harbors division of the
- 14 department of transportation;
- 15 (3) Chief of police of each county police department; and
- 16 (4) Prosecuting attorney of each county.
- 17 (d) The chair shall invite representatives of the
- 18 following federal entities to serve as members of the task

- **8** (e) The task force and their represented agencies may
- 9 plan, coordinate, and engage in law enforcement operations to
- 10 interdict illegal fireworks and the task force shall develop a
- 11 comprehensive strategic plan to stop the importation of illegal
- 12 fireworks and explosives into Hawaii; promote compliance with
- 13 the state fireworks control laws; and ensure the safety and
- 14 security of the airports, harbors, and other facilities and
- 15 institutions in the State against the discharge of illegal
- 16 fireworks and explosives.
- 17 (f) The task force shall submit an interim report on the
- 18 status of its comprehensive strategic plan, including findings,
- 19 recommendations, and any proposed legislation, to the
- 20 legislature no later than twenty days prior to the convening of
- 21 the regular session of 2024. The task force shall submit a

- 1 final report of its comprehensive strategic plan, including
- 2 findings, recommendations, and any proposed legislation, to the
- 3 legislature no later than twenty days prior to the convening of
- 4 the regular session of 2025.
- 5 SECTION 4. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$1,250,000 or so much
- 7 thereof as may be necessary for fiscal year 2023-2024 to carry
- 8 out the purposes of this Act, including the hiring of necessary
- 9 administrative support staff for the task force, operation of
- 10 the task force, and reimbursement of funds to law enforcement
- 11 agencies for task-force-related law enforcement operations,
- 12 including law enforcement personnel, overtime and other salary-
- 13 related payments, charges for fuel, equipment, and storage and
- 14 disposal of confiscated fireworks.
- 15 The sum appropriated shall be expended by the department of
- 16 law enforcement for the purposes of this Act.
- 17 SECTION 5. This Act shall take effect on July 1, 2023, and
- 18 shall be repealed on June 30, 2025.
