## A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the single fastest 2 growing contributor to an increasing cost of living in Hawaii is 3 the rising cost of transportation. Due to increasingly 4 expensive fossil fuels and a lack of cheaper transit options, 5 Hawaii residents already pay among the highest costs to commute 6 in the country. In January 2022, the United States Bureau of 7 Labor Statistics reported that auto-related costs were an 8 astonishing twenty-three per cent higher in December 2021 than a year earlier, accelerating a trend of increasing transit costs 9 10 contributing to Hawaii's rising cost of living.

11 The legislature further finds that numerous public
12 employees commute to work by car and must pay for parking at
13 their workplaces. However, public employees wishing to split
14 the cost of sharing a single stall while carpooling in different
15 cars on different days are currently prohibited by the
16 department of accounting and general services from doing so.
17 Many people are also opting to drive electric vehicles, which

1	are significantly cheaper to operate and maintain than gas-		
2	powered vehicles, and many major manufacturers have already		
3	committed to cease the production and sale of gas-powered		
4	vehicles by 2030 and 2035, respectively. However,		
5	infrastructure for charging those vehicles in the workplace does		
6	not exist.		
7	The purpose of this Act is to:		
8	(1) Help reduce the cost of living and cost of		
9	transportation for public employees by enabling		
10	parking stall sharing between employees; and		
11	(2) Require the department of accounting and general		
12	services to conduct a study to determine the demand		
13	for, and feasibility and costs of, installing electric		
14	vehicle charging stations at newly constructed state		
15	employee and public parking facilities and		
16	retrofitting existing state employee and public		
17	parking facilities to accommodate electric vehicle		
18	charging stations.		
19	SECTION 2. Chapter 27, Hawaii Revised Statutes, is amended		
20	by adding one new section to be appropriately designated and to		
21	read as follows:

1	" <u>§27-</u> Public employee parking facilities. The
2	department of accounting and general services, in collaboration
3	with the department of transportation, shall develop, implement,
4	administer, and manage separate programs to allow two or more
5	public employees of the State to share the cost of a parking
6	stall and allow multiple cars to use that stall as appropriate;
7	provided that the total cost for sharing a parking stall between
8	two or more employees shall not exceed the cost of any one stall
9	for any one employee."
10	SECTION 3. The department of accounting and general
11	services, in collaboration with the state energy office, office
12	of planning and sustainable development, and all state agencies
13	that administer state employee and public parking facilities,
14	shall conduct a study to determine the demand for, and
15	feasibility and costs of, installing electric vehicle charging
16	stations at newly constructed state employee and public parking
17	facilities and retrofitting existing state employee and public
18	parking facilities to accommodate electric vehicle charging
19	stations. The department of accounting and general services may

The department of accounting and general services shall
 submit a report of its findings and recommendations, including
 any proposed legislation, to the legislature no later than
 twenty days prior to the convening of the regular session of
 2024.
