SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF LABOR AND INDUSTRIAL RELATIONS TO COLLECT DATA RELATING TO THE DEVELOPMENT OF AN INFORMATION TECHNOLOGY WORKFORCE IN HAWAII, EVALUATE THE COLLECTED DATA, AND DEVELOP A STRATEGY TO PROVIDE BETTER INFORMATION TECHNOLOGY TRAINING.

WHEREAS, information technology has become a significant 1 component of Hawaii's economy that propels the prosperity of the 2 State as an economic driver that covers a wide range of 3 industries; and 4 5 6 WHEREAS, according to the "Hawai'i IT Workforce Needs Report" published in November 2021 by SMS Research and Marketing 7 Services, Inc., the information technology industry contributed 8 \$2,037,000,000 or 2.2 percent to Hawaii's total nominal gross 9 domestic product (GDP) in 2018; and 10 11 WHEREAS, despite not contributing as much nominal GDP as 12 the real estate, accommodations, and retail industries, the 13 information technology industry had the highest annual real GDP 14 growth rate among all sectors between 2001 and 2018 at 4.9 15 16 percent; and 17 WHEREAS, in 2020, the information technology sector in 18 Hawaii encompassed 12,740 jobs; 3,834 hires; and 894 average 19 annual job openings; and 20 21 WHEREAS, the average hourly wage for Hawaii's technology 22 industry is \$39.92, which is more than double the \$15.53 23 24 survival level hourly wage for individuals in the State as reported in the 2020 ALICE Report for Hawaii; and 25 26 WHEREAS, the United States Bureau of Labor Statistics data 27 shows that the projected increase in computer and technology 28 occupations between 2020 to 2030 is thirteen percent nationally; 29 however, the projected employment increase in the computer and 30

mathematics occupation group in Hawaii between 2018 and 2028 is 1 limited to seven percent; and 2 3 4 WHEREAS, the demand for employees in the information technology field in Hawaii exceeds the number of available 5 individuals seeking jobs in the industry; and 6 7 8 WHEREAS, ensuring that the State's workforce has an adequate and efficient education in information technology is 9 essential for the continued growth of Hawaii's economy; and 10 11 12 WHEREAS, to develop a thriving information technology workforce, the State must improve various aspects of its 13 workforce development programs; and 14 15 WHEREAS, one of the fundamental components of building a 16 robust qualified workforce is the collection of relevant data 17. that will enable better evaluation of available programs and 18 19 contribute to better planning for the future; now, therefore, 20 21 BE IT RESOLVED by the Senate of the Thirty-second Legislature of the State of Hawaii, Regular Session of 2023, the 22 House of Representatives concurring, that the Department of 23 24 Labor and Industrial Relations is requested to: 25 Collect data relating to the development of an 26 (1)27 information technology workforce in Hawaii, which should include but not be limited to: 28 29 30 (A) Courses, trainings, and programs currently being offered in Hawaii relating to information 31 technology; 32 33 (B) Information technology internship programs 34 35 offered by public and private organizations in Hawaii; 36 37 38 (C) Certifications and licenses relating to information technology issued in Hawaii, 39 40 including: 41
