## SENATE RESOLUTION

REQUESTING THAT THE OFFICE OF PLANNING AND SUSTAINABLE DEVELOPMENT ADOPT AND PROMOTE THE UNIVERSAL DECLARATION OF HUMAN RIGHTS.

WHEREAS, the Universal Declaration of Human Rights (UDHR), 1 adopted by the United Nations General Assembly in Paris, France 2 on December 10, 1948, was the first international agreement of 3 the twentieth century to establish fundamental rights and 4 freedoms to which every individual is entitled; and 5 6 7 WHEREAS, the UDHR is a milestone document in the history of human rights and serves as a foundational blueprint for 8 fundamental freedoms and concrete actions that support human 9 rights, demand dignity for all, and respect the rule of law as a 10 foundational principle of governance; and 11 12 WHEREAS, the UDHR: 13 14 15 (1)Represents a collective demand for peace, dignity, justice, and rights; 16 17 (2) 18 Promotes a common understanding of dignity for every individual everywhere, which was collaboratively 19 developed by representatives from different legal and 20 cultural backgrounds of the world; and 21 22 Demonstrates the power of ideas to inspire individuals 23 (3) to take collective action to change the world and 24 25 ensure equality and equity, beginning in one's own community; and 26 27 WHEREAS, to commemorate the seventy-fifth anniversary of 28 29 the adoption of the UDHR, the United Nations Office of the High 30 Commissioner for Human Rights has launched a one-year international campaign highlighting the essential truth that 31 "[a]ll humans are born free and equal in dignity and rights"; 32 33 and 34

WHEREAS, the seventy-fifth anniversary of the adoption of 1 the UDHR will be celebrated in countries, capitals, and 2 communities across the globe as part of a common effort to bring 3 the UDHR to the attention of everyone everywhere; and 4 5 WHEREAS, the anniversary has the potential to rekindle a 6 spirit and sense of solidarity, and rejuvenate a global movement 7 through empowering people to fight for their rights; now, 8 9 therefore, 10 BE IT RESOLVED by the Senate of the Thirty-second 11 Legislature of the State of Hawaii, Regular Session of 2023, 12 that the Office of Planning and Sustainable Development is 13 14 requested to: 15 (1)In coordination with other state departments, adopt 16 the thirty articles of the Universal Declaration of 17 18 Human Rights, in furtherance of the Hawaii State 19 Planning Act; 20 (2) Promote the UDHR to the people of Hawai'i through 21 popular public education; and 22 23 24 (3) Study the feasibility and impact of establishing a Hawai'i Human Rights and Resilience Commission in 25 accordance with the Principles Relating to the Status 26 of National Institutions, more commonly known as the 27 Paris Principles, and submit a report of its findings 28 and recommendations, including any proposed 29 legislation, to the Legislature no later than twenty 30 days prior to the convening of the Regular Session of 31 32 2024; and 33 34 BE IT FURTHER RESOLVED that certified copies of this Resolution be transmitted to the Secretary-General of the United 35 36 Nations, United Nations High Commissioner for Human Rights, President of the United States, Vice President of the United 37 States, United States Secretary of State, Special Presidential 38 Envoy for Climate, Speaker of the United States House of 39 Representatives, President Pro Tempore of the United States 40
