"A BILL FOR AN ACT RELATING TO MEAT DONATION,"

The purpose of this measure is to:

- (1) Allow for the donation of wild game meat, under certain circumstances; and
- (2) Establish a Meat Processing Task Force to develop and implement a plan to expand the meat processing capacity in the State.

Your Committee received testimony in support of this measure from the Office of the Mayor of the County of Maui; one member of the Maui County Council; Hawai'i Farmers Union United; Aina Ho'okupu o Kilauea; Hawai'i Food+ Policy; Hawai'i Farm Bureau; Maui County Farm Bureau; Kohana Family Farms; Hawaii Cattlemen's Council, Inc.; Hawai'i Forest Industry Association; and four individuals.
