"A BILL FOR AN ACT RELATING TO HOUSING,"

The purpose of this measure is to appropriate funds into and out of the Rental Housing Revolving Fund to be used to provide grants or loans to mixed-income rental projects or units for qualifying individuals and families.

Your Committee received testimony in support of this measure from Catholic Charities Hawaii, Partners In Care, NAIOP Hawaii, Hawai'i Association of REALTORS, Housing Hawai'i's Future, and Highridge Costa Development Company. Your Committee received comments on this measure from the Hawaii Housing Finance and Development Corporation.

Your Committee has amended this measure by:

- (1)Changing the appropriations to unspecified amounts;
