The purpose of this measure is to request that the Department
of Human Services Med-QUEST Division expand the types of qualified
providers allowed to provide lactation consultant services for the
Medicaid population of the State.

Public Health Institute, The Academy of Lactation Policy and
Practice, Hawai'i Medical Service Association, and one individual.
Your Committee received comments on this measure from the
Department of Human Services.

Your Committee has amended this measure by:

- (1) P2 Line 24-25 remove "expand the types of qualified
providers,;"

- P2 line 28 remove "credential" and replace with "expand access to" and;
- P2 Line 29-30 delete "or Certified Lactation Counselor certification"
