Exempts a public utility and water carrier from obtaining the required public utilities commission authorization when disposing of a fully depreciated asset or property with a zero net book value. Effective 6/30/3000. (HD1)

RELATING TO CONSUMER PROTECTION.

Requires check cashers to report suspected financial exploitation of elders and vulnerable adults in relation to check cashing. Authorizes a check casher to refuse to cash a check in situations of suspected financial exploitation. Provides immunity for check cashers acting in good faith. Effective 6/30/3000. (HD2)

Establishes the common-interest development oversight task force to examine the feasibility of bringing the various common-interest developments in the State under the oversight of the department of commerce and consumer affairs and investigate whether additional duties and responsibilities should be placed on members of boards of directors for cooperative housing corporations. Effective 6/30/3000. (HD2)
