Requires that the University of Hawaii ensure that any individual
who participates in implementing the university's disciplinary
process has training or experience in handling sexual
misconduct complaints and the university's disciplinary process.
Requires that the university provide mandatory annual trauma-
informed, gender-inclusive, LGBTQ+-inclusive sexual
misconduct primary prevention and awareness programming for
students and employees of the university. Prohibits the
university from taking disciplinary action against individuals
reporting sexual misconduct unless certain exceptions apply.
Establishes positions and appropriates funds. Effective
6/30/3000. (HD2)
