- Appointed as the Adjutant General, State of Hawaii, Department of Defense from December 2019 to present.
 - March 2020 to March 2022 served as the State of Hawaii's incident commander for COVID-19 response.
- Appointed as the Deputy Adjutant General, State of Hawaii, Department of Defense from January 2015 to December 2019.
 - In 2018 served as the Dual Status Commander, in charge of Active Duty and National Guard units for the Kilauea volcanic eruption and Hurricane Lane disaster response.
 - 2018-2019 concurrently served as the commander of the Hawaii Army National Guard and the Deputy Chief of Staff, Army National Guard, Operations G3, Eighth US Army, South Korea.
- Led the Hawaii National Guard's publishing of the Multi Hazard Emergency Response Plan and Hawaii National Guard Strategic Planning
- Led the Hawaii National Guard Joint Staff during National Guard Domestic Operations in response to Hurricane Iselle, Hurricane Ana, and the ongoing Puna lava flow
- Commanded the 29th Infantry Brigade Combat Team (IBCT) - the largest deployable unit in the Hawaii National Guard.
 - Mobilized and deployed 16 Security Force Assistance Advisor Teams (SFAT) to Afghanistan, 2012 – 2013 in support of Operation Enduring Freedom

 - Overall responsible for the training and readiness of 5,500 Soldiers and Airmen of the Hawaii National Guard
 - Coordinates activities with county emergency management agencies and other public and private organizations dealing with emergency management

- **Deputy Adjutant General**, State of Hawaii, Department of Defense -- 2015 to 2019
 - Primary advisor to the Adjutant General
 - Managed and directed the administration and operations of the department – with the exception of the Hawaii Emergency Management Agency, about 500 state employees, and oversaw state and federal budgets for the department.
 - Developed the department's strategic plan
 - Led the department's strategic communication plans and operations

 - Manages and directs the administration, coordination, planning, development, execution, and supervises the Hawaii National Guard Joint Staff
 - Responsible for the day to day operations and activities applicable to the Hawaii National Guard
 - Develops long and short range plans
 - Develops, implements, and communicates Hawaii National Guard policies for subordinate organizations
 - Advises the Adjutant General of the State of Hawaii on all Hawaii National Guard training, missions, and functions
 - Makes complex decisions regarding allocation of resources for Hawaii National Guard programs
 - Collaborates and coordinates closely with the intergovernmental groups, county government officials, and emergency managers on emergency management matters
 - Assists with the department's strategic communications strategy, plans, and execution. Conducted media interviews; provided informational briefings to community groups and the mayors of Hawaii, Maui, and Kauai Counties; and provided presentations governmental and non-governmental agencies

- **Commander**, 29th IBCT, Hawaii Army National Guard, Kapolei, HI -- 2011 to 2013
 - Ensured that the brigade and SFAT were at the highest levels of readiness for deployment
 - Effectively planned, organized, directed, controlled, and coordinated the 3,500 soldier brigade
 - Successfully mobilized, deployed, and redeployed 16 SFATs (187 personnel) and equipment from Home Stations in Hawaii, Arizona, and Guam for post-mobilization training and validation in Camp Shelby, Mississippi; Fort Polk, Louisiana; the National Training Center, Fort Irwin, California; and successfully deployed to Regional Command South, Afghanistan. Redeployed 100% of personnel and equipment safely back to home stations in Hawaii, Arizona, and Guam
 - During the same period detailed as the full-time Chief of the Joint Staff of the Hawaii National Guard
 - Collaborated and coordinated with the multiple Family Readiness Groups, family members, and employers and ensured that programs and resources were made available to all

 - Ensured the battalion remained at the highest level of readiness prior to and throughout its deployment to Baghdad Iraq
 - Successfully mobilized, deployed, and redeployed all units (over 600 personnel), and equipment from home stations to Schofield Barracks; Fort Bliss, Texas; Fort Polk, Louisiana; Camp New York, Kuwait; Victory Base Complex, Baghdad, Iraq. Successfully redeployment 100% of personnel and equipment safely back to home stations
 - Appointed for 30 days as Task Force – Hawaii commander that led a joint Army and Air National Guard battalion sized element in response to the October 2006 earthquake. Worked closely with the people of Hawaii, County of Hawaii and State of Hawaii leaders, first responders, and non-governmental organizations.
 - Immediately following the October 2006 earthquake participated in the Rising Warrior Exercise – a 22 day multilateral field training exercise with the Japanese Ground Defense Force
