EIS rules which included public disclosure of multiple drafts of the rules, an online and in-person commenting process, many public meetings, and several informational sessions to assist with transition from the old rules to new rules.

While at the State Energy Office (SEO), Scott continued his support of the EAC and makes himself available to offer his assistance when needed. Even though he is extremely busy, Scott is very generous with his time and gives his all to his work and serving the people of Hawai'i. The EAC is confident that it will continue to receive the support and leadership that it needs with Scott at the helm of the OPSD.

Scott's experience both in the public and private sectors make him the right person to lead the OPSD. Scott has served on the State Climate Change Mitigation and Adaptation Commission since 2017. The OPSD, along with its attached agencies and boards and commissions, plays an important role in Hawai'i's planning future and navigating through the changes that Hawai'i is experiencing now and will continue to experience with climate change. I am Gerald A. Sumida, a partner of the Hawai'i-based law firm of Carlsmith Ball LLP, and I am very pleased to present this testimony in very strong support of the confirmation of Scott J. Glenn to the position of Director of the Office of Planning and Sustainable Development of the State of Hawai'i.

I became familiar with Scott when he was the Chief Energy Officer of the State of Hawai'i and led the Hawai'i State Energy Office (HSEO), and interacted with him on various statewide energy planning and development matters. This letter is to express Par Hawaii's support of the nomination of Scott Glenn to Director, Office of Planning and Sustainable Development. Par Hawaii is a leading supplier of fuel products in Hawaii. We operate a refinery in Kapolei, producing fuels for a range of customers including Hawaii's utilities, airlines, marine and trucking fuel users and others. We operate a fuel distribution network serving the islands of Hawaii, Kauai, Maui, Molokai and Oahu. Our company also operates convenience stores and sells fuel under the Hele and 76 brands.

I have known and worked with Mr. Glenn since late 2019 when he was named Chief Energy Officer. Here are a few examples of our experience working with Mr. Glenn.

- The pandemic sent shock waves through the energy industry, as travel ground to a halt. Our company, as well as Hawaii's utilities, confronted sudden and drastic changes to energy demands. We were able to navigate these challenges and continue the reliable and secure supply of fuel. During this time, we were frequently in touch with Mr. Glenn and his colleagues at the State Energy Office. Mr. Glenn and his team were balanced and thoughtful as we worked through this period.
- In the wake of Russia's invasion of Ukraine in February 2022, our company made the decision to cease purchases of Russian crude oil. In prior years, approximately 20-25% of our crude oil was sourced from Eastern Russia because of its relatively high yield of jet fuel, and because of its proximity to Hawaii. Crude is purchased months in advance of delivery, so at the time of the invasion we still had previously committed cargos en route to Hawaii. Mr. Glenn was a critical conduit between our company and State and Federal policymakers. While the Biden Administration and the US Congress examined policy options to sanction Russia, Mr. Glenn provided advice to ensure that Hawaii's energy supply would remain uninterrupted.
- While we did not always agree with Mr. Glenn's, or the State Energy Office's, stances on policy matters, Mr. Glenn was always willing to listen to and take into account our concerns and perspective. We found him to be practical and realistic, putting the needs of Hawaii first.
- Mr. Glenn has also been a good partner as we have explored options to repurpose units at our refinery to produce renewable diesel or sustainable aviation fuels for the Hawaii market.

In summary, we strongly support Mr. Glenn's nomination to Director, Office of Planning and Sustainable Development. I would be happy to expand on the above points, or answer any questions you have.

I have known Scott for over 15 years and have worked with him in private practice and in the public service. He is smart, passionate, balanced, fair, and an open-minded listener who can get things done. Scott cares about Hawaii's sustainable growth enough to have initiated "Better Block Hawaii", a nimble nonprofit the helps local communities improve their sense of place by making smart, spatial innovations like parklets to brighten and beautify neighborhoods, enhance open space, and create inviting, vibrant places to live, work, eat, gather and play.

My name is Ryan Toyomura and I am an attorney with the law firm Ashford & Wriston LLP, testifying in my personal capacity **in strong support** of the confirmation of Mr. Scott Glenn as Director of the Office of Planning and Sustainable Development.

I had the pleasure of working with Mr. Glenn when he was Director of the Office of Environmental Quality Control (k/n/a the Environmental Review Program) while I was the senior advisor to the Senate Committee on Housing (the "Committee"). To meet the formidable goal of the Special Action Team on Affordable Rental Housing's recommendation of 22,500 units by 2026, an infusion of capital and bold policies was desperately needed. The Committee identified numerous challenges to affordable housing development including funding, infrastructure, and outdated environmental rules to name a few.

Having responsibility over administering the state's environmental review program (Chapter 343, <u>Hawaii Revised Statutes</u>), Mr. Glenn played an active role in engaging the Committee as it considered various proposals to amend the environmental assessment (EA) and environmental impact statement (EIS) law to better position the State's ability to meet its housing needs. This was no easy task given the perceived polarization between development and environmental protection. However, due in part to Mr. Glenn's leadership and willingness to be part of the solution, affordable housing developments now enjoy limited exemptions from EA/EIS requirements under Section 11-200.1-15, <u>Hawaii Administrative Rules</u>.

Mr. Glenn was successful at balancing the needs between building homes quicker to address the state's housing crisis with protecting our environment and natural resources. I believe his thoughtful approach to planning, energy, the environment, and leadership will greatly benefit the OPSD and the State. Through the countless hours I spent with Mr. Glenn on our housing issues, I can attest to his commitment to public service. Therefore, I respectfully ask this committee's affirmative recommendation to advise and consent his nomination as Director of the Office of Planning and Sustainable Development.

I aloha and malama our environment. I am a Hilo resident and climate activist. I oppose GM 506.

Hawaii has needed an energy plan for years. We have limited aina and many goals requiring the use of clean energy sources to reduce Hawaii's greenhouse gas emissions and become energy indepedent. The RPS law, puna geothermal's plant, the protests against wind turbines, and the closure of Oahu's coal plant all show the need for an energy plan. During the 4 years as the Chief Energy Officer leading the HSEO, Scott Glenn did not publish an energy plan. Now you want him to lead the Planning Office? 'Auwe!

In Moku o Keawe we were without electricity for over a week last summer. We were ordered to conserve electricity at night during peak times when we cooked dinner and needed light. My kids and I sat in the dark many nights. We couldn't run the fans during humid Hilo nights. Restaurants and businesses in downtown Hilo had their lights off and lost costumers. It was humbug, and that was only a week of rolling blackouts! Scott Glenn as the State Chief Energy Officer did nothing. The State Energy Office did nothing. The state government did nothing. There was no accountability with HELCO, and no punishment or credits for these impacts with their customers. I heard similar rolling blackouts happened on Maui last summer too!

Just wait for Oahu to have a taste of the rolling blackouts we had on our islands! Scott Glenn's poor energy planning will finally make the news then!

In 2020 he supported the closure of Oahu's coal plant, and assured the public in his testimony that energy supply and contigency was expected to be sufficient for grid stability with the retirement and removal of Oahu's coal plant. A year later, PUC Chair Jay Griffen chastised HEI for the lack of planning of energy supply and contingency as Honolulu prepared for the coal plant's closure, saying, "your plan to me amounts to a shift from one fossil fuel to another. *We're going from cigarettes to crack*." Where was Chief Energy Officer Scott Glenn or the Hawaii State Energy Office who are required to provide planning on renewable energy and energy resiliency? He resurfaced to later **applaud** the coal plant's shut down in September 2022, but was again no where to be found when HECO issued their 7% residential electricity rate increase due to the coal plant's closure. The PUC now anticipates rolling blackouts because of Oahu's reduced energy supply.

Chief Energy Officer Scott Glenn and the State Energy Office assured the public that there would be energy supply and contingency, there wasn't. HECO is now reliant on *more* fossil fuels, not less. Residents are paying *more* for electricity because of this closure and his testimony. There is no energy plan and there are rolling blackouts across the islands. Because of his testimony in support of the plant's closure, he has already directly raised the cost of living in Hawaii. This person is not an effective planner or leader for the State. He does not consider or plan for equity in his climate advocacy. After raising the cost of living, he should not be considered to lead anything in state government, let alone an important land use agency like the State Office of Planning and Sustainable Development. I write in support of GM 503, nominating Scott Glenn to lead the Office of Planning and Sustainable Development

I specifically appreciate Mr. Glenn's past experience with Chapter 343 of the Hawai'i Revised Statutes, as a graduate student at the University of Hawai'i, his internship at the then-Office of Environmental Quality Control, his later Directorship of OEQC, and his overall experience with these and similar planning laws in the state.

I have some general comments. One of the state's greatest political weaknesses is its overreliance and over-specialization with chosen (literally appointed) technocrats. The state therefore lacks a deep bench of experience, confounded by its own prohibitive cost of living and narrow professional class, many of whom intentionally or otherwise become gatekeepers, and a public culture of apathy (or learned helplessness). Hawai'i always ranks far lower on volunteerism than its west coast neighbors.

This is a hierarchical culture that jealously guards underlying information and decision-making. It is outdated for the 2020s and the profound threats that civilization endures.

Specifically as it relates to planning, take as evidence the sad state of O'ahu Metropolitan Planning Organization (O'ahuMPO) over the years. Is was the only MPO to be decertified by federal authorities in the 1970s, and was then nearly decertified yet again in the 2010s before I joined it. Other MPOs manage regional parks, zoos, construction waste recycling, and levy multi-million dollar (or billion dollar) bonds. O'ahuMPO has to constantly fight to not be the stepchild of the engineering-heavy state Department of Transportation.

Consider also that much of the public does not trust 'planners' or planning, per se, insofar as recent foibles show: Mānoa Banyan Court, Sherwood Forest, Ala Moana Beach Park, Banyan Drive, the Coco Palms Resort, and the Kuilei Place development. As a fellow planner, I believe this is partly due to misunderstanding, and partly due to the scapegoating of the professional

duties and experience of urban planners on hehalf of the perceived errors of politicians and developers. Planners are the middle men in this dysfunctional dynamic.

I write all of this because any incumbent, no matter how experienced or knowledgable, is up against a series of problems that are greater than the indiivdual. But to answer these political problems with one's own performance measures is a self-reinforcing loop.

This is not a problem of qualification, but one of vision.

The creation of OPSD was a counterreaction to the past demotion of Planning, which, long before our time, used to be a state-level or department-level function in its own right. The obvious next correction is a stronger democratization of the planning process. OPSD has a critical role in fostering this moral and political need.

Such a change would be a stark contrast today, where the public engages with planning reactively (with a negative bias) instead of proactively. Imagine a future where the public has a stronger participatory role in project formation, design, and support, with accompanying buy-in. Planners already support such efforts locally, but lag far behind progress made nationally in other similar-sized jurisdictions.

Comments:

I am a long time employee of the OSP/OP/OPSD for over 25 years. I am submitting my testimony anonymously in opposition to GM 506 to avoid retribution from the nominee.

For the past 3 months, I observed Mr. Glenn serve as the OPSD Director and watched him ignore the knowledge and recommendations from long-time civil servant employees, supress employee suggestions, micromanage staff, and decrease the morale in the agency. Recently, a land use planner who served the State of Hawaii for 40 years resigned suddenly at the end of February under Mr. Glenn's leadership. Mr. Glenn has also openly acknowledged that he is not familiar with land use laws, other key statutes, or the responsibilities of the OPSD.

I am concerned that Mr. Glenn is unsupportive of long time, experienced employees and may intend to supress and encourage them to leave in order to replace them with ill-experienced staff. This is problematic since the OPSD and other land use agencies are highly reliant on the OPSD's institutionalized land use knowledge and history. I consulted long time Energy Office employees who confidentially confirmed there was a significant turnover rate and similar management style under his previous leadership as the Chief Energy Officer.

In the 3 months under his leadership at the OPSD, morale became very low. With Mr. Glenn as Director, the agency no longer functions or holds the same policy positions as it was previously led. Staff are frustrated with Mr. Glenn, they do not feel heard or supported, and there are many employees who are considering to retire, transfer, or resign from the OPSD if Mr. Glenn is confirmed as OPSD Director by the Senate.

Mr. Glenn may be an urban planner, but is not fit to lead the OPSD. The agency will likely fail or crumble during his tenure if he continues to serve as Director. Please consider rejecting GM 506 for the sake of the office's history and future.

Comments:

I am a civil servant employee in the Office of Planning and Sustainable Development. I am testifying anonymously to avoid retaliation in the workplace.

I oppose GM 506. The nominee lacks land use experience. His previous experience leading the OEQC and the HSEO related solely on environmental matters, the management and review of EISs and EAs, and advocate for select clean energy projects. Our agency worked with the HSEO over the past 4 years on various land use dockets that included clean energy proposals, and the nominee rarely engaged with Land Use Commission dockets or project proceedings.

The OPSD is in a transition to fulfill its new mandates enacted in 2021, which include environmental review, sustainability, sea level rise adaptation, and climate change. While the nominee may be passionate on these matters, he lacks the knowledge and background to incorporate these values in land use policy. Many of my co-workers were encouraged with the passage of Acts 152 and 153, and the identification and investment of land use planning and OPSD's ability to provide statewide coordination to assist the State of Hawaii to equitably adapt to climate change. Instead, OPSD employees are now disillusioned with policy position changes this legislative session and the nominee's disregard of employees' institutional knowledge and subject matter experience. OPSD employee morale is low, a land use planner retired just last week. Other planners and staff are considering their own departure if the nominee is confirmed to continue to lead the OPSD.

The nominee is a passionate advocate with a strong environmentalist background, but is inexperienced with planning, land use laws and jurisdictions, climate adaptation, and coastal zone management. I encourage the committee and the Senate to not advise and consent to the nomination in GM 506.

I have worked with the Office of State Planning in the past, and since my retirement I followed along with the transition of this great office from the Governor's Office of State Planning, the DBEDT-attached agency Office of Planning, and the excitingly new Office of Planning & Sustainable Development (OPSD)!

I am also a strong supporter of taking action on the climate crisis.

However, I and other planners within Hawaii's planning community are becoming increasingly concerned with the OP's Director. Aloha e Chair Inouye, Vice Chair Elefante, a me the Honorable Senate Members of the Committee on Water and Land,

I came to know Scott Glenn in the summer of 2018 while participating together in the Climate Security (Mitigation) Working Group for the City and County of Honolulu Office of Climate Change, Sustainability and Resiliency, from which the *Ola: O'ahu Resilience Strategy* was then created.

At the time, I was the Regional Manager for ENGIE, a multinational clean energy company that had done various energy efficiency and renewable energy projects in our Islands, and Scott was the Director for the Office of Environmental Quality Control.

Scott struck me as a soft-spoken yet well-informed person who understood not just the nuances of local policies and their impacts, but also the larger global frameworks surrounding climate change-related policies as well as the science that supported stronger action at international gatherings such as the pivotal Conference of Parties.

Throughout the ensuing years as Scott and I stayed in touch, he was appointed to the Chief Energy Officer position with the Hawai'i State Energy Office. It was in this capacity that we had a fair number of discussions regarding the importance of a holistic approach to carbon emissions reduction, e.g., how clean energy must play a large role in addressing the climate crisis to try to hold the line at 1.5C for island and coastal communities; how Hawai'i could be a clean energy lighthouse for the world; how utilizing critical data could help inform elected decision makers, the utility, and developers. Moreover, we had candid discussions about clean energy in all its scales and forms – from utility-scale renewable energy to commercial-scale energy efficiency measures, from energy storage and electrification of transportation to the importance of prosumers in the equation and leveraging non-tax-payer capital to tackle necessary but capital-intensive projects, and more.

What I appreciated about Scott's perspective on clean energy was that he viewed carbon as the ultimate metric from which to be measured, and all forms of clean energy were a collective tool kit used to drive down emissions, while also lowering our dependence on imported fossil fuels, creating good local jobs, and keeping our hard-earned dollars in our local economy.

No one is without areas of improvement, and one that I felt Scott could have done a better job in while at the HSEO was harnessing the power of storytelling – using stories to connect local folks with projects and policies to help elevate the good work that was being done, to share out State strategies that would reduce emissions in a shorter period of time, and to demonstrate that Hawai'i could, indeed, be the lighthouse of clean energy. There is a saying: "no story without data, and no data without a story." I believe Scott understands this, which is why he was beginning to put in place some key attributes to the HSEO that were starting to unleash the power of story, such as the overhauling of the website for ease of navigation, highlighting their data visualization tools via their Open Data Portal, commencing their Clean Energy Wayfinders program, and more.

Scott brings various transferable skills both from his previous experience in the private sector, and his two directorships for the State. He has both the broad-based understanding of government and its roles/limitations, as well as the ability to hone-in on detailed matters so that problems can be identified, a collaborative plan can be created, and then properly execute on said plan while measuring and verifying impact so that tweaks can be made as necessary.

I look forward to Scott's continued leadership for our State, and how he can provide critical thinking and action for the OPSD in order to ensure that we have smart, sustainable, resilient, and holistic planning and development across our Islands.

I strongly support Scott's confirmation as the Director of OPSD.

Chapter 225M, charges the Office of Planning and Sustainable Development with coordinating the implementation of Chapter 226, the Hawaii state Planning Act to maintain a strong economy, balance protection of Hawaii's physical environment with the need for facilities to support Hawaii's families and socio-cultural advancement for all of Hawaii's residents. Finding the right balance as new concerns arise requires the ability to listen to a broad spectrum of voices in the community.

Scott Glenn has training and experience in all the areas required by the Legislature in Chapter 225M to serve as the head of the Office. Scott has a Master of Urban and Regional Planning from UH Manoa, and served as the head of two state programs, the Office of Environmental Quality Control and the Hawaii State Energy Office.

Aloha. My name is Wren Wescoatt. I am from Ualapu'e, Molokai and currently reside in Manoa, Oahu. I serve as Vice President of Development at Longroad Energy and have spent the past 15 years working with several companies and local communities to develop some of the largest clean energy projects now operating in our state.

Even though most people know it is important to move away from fossil fuels and toward renewables, developing large solar and wind energy projects is incredibly difficult, because there are different stakeholders and competing land use priorities. As head of the State Energy Office, Scott Glenn facilitated discussions about clean energy and looked for solutions that made sense for community members, government agencies, utilities and renewable energy companies. As a planner, he understood our collective need for housing, agriculture, energy, business, recreation and open space. Scott excelled at leading difficult conversations, getting disconnected groups coordinated and opposing groups to agree on common ground.

Another challenge for renewable projects is the need to get approvals from many government agencies at the county, state and sometimes federal levels.
