I have the great honor to support the confirmation of Sabrina Nasir to be Deputy Director for the Department of Budget and Finance for the state of Hawaii. Sabrina worked with me at the East-West Center on two projects: as Project Coordinator of the Indo-Pacific Perceptions of Messaging program, and as the Coordinator of the Diversity, Equity, and Inclusion (DEI) initiative. In both positions, Sabrina exhibited the utmost professionalism, creativity, competence, and meticulousness. Her efforts were indispensable to each of these two projects.

The Indo-Pacific Perceptions of Messaging program was sponsored by the Department of State, and its purpose was to refine U.S. messaging across Asia and in the Pacific. It was considered the essential State Department Public Diplomacy initiative of 2019 to 2021, as State struggled to put forth a message that resonated with citizens in the host countries where U.S. Embassies had been established. Through a number of ingenious and original probability and polling devices, Sabrina was able to gain insight into the real effects that U.S. messaging was having on Indo-Pacific peoples; and just as importantly, showed the differences in such messaging in each country. It also showed the way forward on how to much better refine U.S. messaging to make it far more effective. I said many times to the State Department, to other East-West Center employees, and to Sabrina that, as a U.S. Ambassador, I would have loved to have had these tools at my disposal. Similarly, the State Department was thrilled to have these tools at its disposal; and since Sabrina left the East-West Center, has asked the East-West Center to continue with other similar initiatives across the Indo-Pacific region. I attribute the program's great success solely to Sabrina's hard work and inventiveness.

Soon after I started working at the East-West Center in late 2020, it was apparent that DEI was becoming a particularly important initiative that was percolating from the bottom up. A DEI survey had been distributed to all employees, the results were tabulated, and there was a clear consensus that DEI needed to be better integrated into the fabric of East-West Center processes and procedures. A DEI committee was formed, but it became evident that more focus was needed, so I made the decision to create a DEI Coordinator. Sabrina expressed interest in the job, and I knew that she would be the person who could best organize the DEI program and integrate it into the East-West Center, so I enthusiastically accepted her appointment. I was right – Sabrina brought competence, persistence, steadfastness, creativity to the job, and firmly anchored DEI in

the East-West Center by the time she moved on to her next position. She was outstanding, and I can't imagine that anyone else would have been able to do a better job than she did.

I know that Sabrina can do any job that she sets her mind to, and do it fabulously well. I have no reservations whatsoever in giving her my highest recommendation for the Deputy Director of Budget and Finance position.
