Aloha Chair McKelvey, Vice-Chair Gabbard and Members of the Committee on Government Affairs:

I am Keali'i Lopez, testifying in strong support of GM 533, in personal capacity. I had the honor of working very closely with Ms. Silliman at the Department of Commerce and Consumer Affairs (DCCA) while I was the Director of DCCA from December of 2010 through December of 2014. From the very start Meoh-Ling was proactive and effective at orienting and preparing me for the fiscal oversight and responsibility required of the Department Director. Within a short period of time, I was well equipped to discuss and defend the Department's budget in January of 2011.

Meoh-Ling walked me through the numerous DCCA funding sources, budget codes, understanding DCCA's self-sufficiency related to the various special funds of the department and building ownership. More importantly, Meoh-Ling demonstrated her ability to work with DAGS in our join building management. Though funds provided by DCCA were used to purchase the Kalakaua Building, the building was held by and maintained by DAGS. It was not unusual for Meoh-ling to have to explain this many times whenever building repairs or maintenance was needed. Adding the complexity of who was responsible for maintaining the build, was that fact that it was a joint ownership with the US Postal service. Meoh-Ling represented DCCA's interest in joint tenancy/ownership matters USPS. She was therefore very fluent in understanding the property maintenance requirements, capital appreciation and matters dealing with tenants.

Most importantly, I found Meoh-Ling to be very thoughtful and focused on customer service. She understood her role and was committed to her internal clients (myself, DCCA deputy and division chiefs).
