Re: G.M. No. 562

The Hawai'i Civil Rights Commission (HCRC) has enforcement jurisdiction over Hawai'i's laws prohibiting discrimination in employment, housing, public accommodations, and access to state and state funded services. The HCRC carries out the Hawai'i constitutional mandate that no person shall be discriminated against in the exercise of their civil rights. Art. I, Sec. 5.

G.M. No. 559 submits the nomination of Arsima Muller to the Hawai'i Civil Rights Commission, for Senate consideration and confirmation.

The statutory qualifications for HCRC Commissioners are set forth in HRS § 368-2(a): "The members appointed to the commission shall be selected on the basis of their knowledge and experience in civil rights matters and on the basis of a demonstrated commitment to the preservation of the civil rights of all individuals."

HCRC staff are appreciative of the willingness of Arsima Muller to serve as an HCRC Commissioner. Ms. Muller brings a wealth of experience and expertise to the Commission, and an impressive record of demonstrated commitment to civil rights for Hawai'i's people and the people of Micronesia. She will contribute a valuable perspective on civil rights as they impact members of our community who are from Micronesia and Compact of Free Association (COFA) nations. Her knowledge of the legal system is also helpful.

She has an impressive history of work in law and advocacy. Since her appointment, she has been conscientious and engaged while serving pending confirmation.
