Testimony of DAWN N. S. CHANG Chairperson

Before the Senate Committee on HAWAIIAN AFFAIRS

Tuesday, April 4, 2023 1:00 PM State Capitol, Conference Room 224 and Via Videoconference

In consideration of GOVERNOR'S MESSAGE 566 SUBMITTING FOR THE CONSIDERATION AND CONFIRMATION TO THE ISLAND BURIAL COUNCIL, ISLANDS OF MAUI AND LĀNA'I, GUBERNATORIAL NOMINEE, SCOTT FISHER, FOR A TERM TO EXPIRE 06/30/2026.

The Department of Land and Natural Resources (Department) strongly supports Governor's Message 566, nominating Mr. Scott Fisher to the Island Burial Council, Islands of Maui Lāna'i expiring June 30, 2026.

The Island Burial Councils (Councils) are established under Section 6E-43.5, Hawai'i Revised Statutes. The Councils determine whether to preserve in place or relocate previously identified native Hawaiian burials site, recognize lineal and cultural descendants, and provide counsel and advise to the Department. With the exception of the Moloka'i Island Burial Council, the Councils consist of no more than nine members, of which no more than three representatives shall be representatives of development and large landowner interests. Mr. Fisher is seeking a large landowner seat.

Dr. Fisher was born and raised in Kula, Maui, is part Native Hawaiian, and has dedicated his life to the protection and stewardship of Hawai'i's natural and cultural resources. He is employed as the Director of 'Āina Stewardship for the statewide nonprofit land trust Hawai'i Land Trust (HILT), overseeing stewardship and restoration of natural, cultural and historic resources on HILT's eight preserves statewide. Dr. Fisher has restored native coastal ecosystems on HILT's preserves to protect iwi kupuna in place and stop coastal erosion. He works with descendants of areas in which HILT's preserves are located to protect iwi kupuna, reinter with appropriate protocols and descendant involvement in rare instances when iwi kupuna become exposed due to natural erosion, and has welcomed reinterment on HILT's preserves of iwi kupuna that have been exposed on other lands that don't offer permanent protection.

Dr. Fisher holds a Graduate Certificate in Ecological Restoration, a Ph.D. in Peace and Community Development Studies, a M.A. in Peace Studies, and a B.A. in Philosophy, with a concentration in Religious Studies. In addition to his educational background, and long land stewardship career with HILT, Dr. Fisher has also assisted other community organizations and agencies, such as developing and implementing an extensive oral history grant for the Maui Historical Society. Dr. Fisher is currently serving as the Chair of the Maui Lāna'i Islands Burial Council. As a member, Vice Chair, and now Chair, he has earned the respect of both his fellow burial council members and the general Maui Community.

Senate confirmation will ensure that Mr. Fisher's knowledge and perspective informs the deliberations of the Maui Lāna'i Islands Burial Council until June 30, 2026.
