Kaneohe Bay is a sacred wahi pana to native Hawaiians of Ko`olaupoko, and Jo-Ann's dedication to the health and welfare of the Bay and its environs and commitment to the people who live there and in the Kãne'ohe Bay region have been consistent threads throughout her time as Director of the Hawaii Institute of Marine Biology.

Until her tenure as Director from 2001-2014, HIMB was seen by community members as a place for scientists apart from the people of Kaneohe. Jo-Ann aimed to change that perception and to welcome the entire Kaneohe community to Moku o Lo`e, popularly known as Coconut Island.

Not only that, she found time to serve on the boards of Paepae o He'eia, Kako o' Oiwi, and the Ko'olapoko Hawaiian Civic Club. She and Jonathan Kanekoa Kekua Shultz proposed the designation of the National Estuarine Research Reserve (NERR) site at He'eia and that proposal was selected for the federal designation process by the state.

It's not every day that HCDA has the opportunity to have someone with Jo-Ann's background serve on the Heeia District.

For these reasons, we STRONGLY URGE you to confirm this extremely qualified person.

The Ko'olaupoko Hawaiian Civic Club was established in 1937 and is one of the largest in the Association of Hawaiian Civic Clubs nationwide. Ko'olaupoko HCC is a not-for-profit community organization dedicated to preserving and perpetuating the history, heritage and culture of Native Hawaiians and providing leadership and scholarships. Its membership is open to people of Hawaiian ancestry and those who are "Hawaiian at heart."
