#### In consideration of GOVERNOR'S MESSAGE 582 SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE KĀNE'OHE BAY REGIONAL COUNCIL, GUBERNATORIAL NOMINEE, JOSEPH PICKARD, FOR A TERM TO EXPIRE 06-30-2025

The Department of Land and Natural Resources (Department) supports Governor's Message 582 nominating Mr. Joseph Pickard to the Kāne'ohe Bay Regional Council for a term to expire on June 30, 2025.

Pursuant to Section 200D-2, Hawaii Revised Statutes, the Kāne'ohe Bay Regional Council was established to, among other things, facilitate the implementation of the Kāne'ohe Bay Master Plan as it relates to ocean use activities and advise and make recommendations to the State and the County on matters regarding the use of Kāne'ohe Bay by the general public, marine research programs, and commercial ocean use activities, including legislative matters. Membership on the Council includes government officials, area neighborhood board members, and individuals representing user groups of the Bay.

Mr. Pickard is a Native Hawaiian business and community leader and was the former president of the Kāne'ohe Business Group and a past member of the Kāne'ohe Bay Regional Council. Mr. Pickard grew up on O'ahu and joined the Coast Guard in 1978, a career that led him to Miami, Florida and, eventually, to Columbia University in New York where he obtained a Master's Degree in Engineering. After a brief tenure in investment banking, which took him to Tokyo and Hong Kong, Mr. Pickard returned to O'ahu where he started and acquired several businesses such as Sea Hawaii Inc., Environet, and Community Planning and Engineering.
