Subject: State Council on Mental Health

Dear Senator San Buenaventura,

Thank you for the opportunity to respond to your questions regarding my interest in the State Council on Mental Health. Please find below my answers to your questions with regards to the State Council on Mental Health.

(1) Why do you wish to be a member of the State Council on Mental Health?

I have a personal interest in improving mental health services in Hawaii. I have a sibling and his wife who lived in the state for more than 12 years and suffered from serious mental health illnesses. One suffered from bipolar disorder and the other suffered from schizophrenia. During acute instances, I tried many times to obtain health services for them, however the law precluded services at the time. As such, I am glad to see some improvements in mental health laws, including ACT; some of which I was fortunate to work on with other committed individuals.

(2) How do you perceive the role and responsibilities of a member of the State Council on Mental Health?

I believe the State Council should look at ways to improve services in Hawaii to those with mental health issues. Moreover, we should advise the Department of Health (DOH) on how to improve their mental health services, in addition to preparing annual and long-term mental health plans for Hawaii. (3) Given your understanding of the role and responsibilities of a member of the State Council on Mental Health, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the State Council on Mental Health.

In addition to helping family members deal with mental illness in Hawaii, by being involved in mental health nonprofit organizations, I have experiences in organizational budgeting and planning. Specifically, I've been on the board of Mental Health America of Hawaii for over 25 years; for about 12 years I've been on the Hawaii Protection and Advocacy for Individuals with Mental Illness advisory board; and am currently serving on the board of Hawaii Disability Rights Center. I've also participated in several informal committees of individuals that are interested in improving Hawaii mental health laws. Finally, I have budgeting and planning experiences at different organizations.

(4) What do you hope to accomplish during your term of service?

I hope to help conduct an extensive review of mental health laws to see if they serve their purposes, develop laws to aid those with mental illness, and modify laws that would more effectively serve this population. I also hope to help improve services for those suffering from mental illness, including in-patient and out-patient. This includes developing short- and long-term plans to meet these needs.

(5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the State Council on Mental Health?

I will discuss three qualities: assertive, integrity, and an understanding of the State of Hawaii legislative process.

Assertive: I will take action to do what needs to be done to improve the State's mental health.

Integrity: I will always do what I believe is right for our population and the State of Hawaii.

Understand the legislative process: This will help SCMH review, change, or initiate laws to benefit the mentally ill.

(6) Name one previous experience that would make you stand out. How would this benefit the State Council on Mental Health?

When my niece was about 3 years old her mother had a psychotic break. Her dad was taking care of her mother and I was taking care of my niece. My niece asked me "If my mom couldn't take care of me who would take care me?" This question profoundly affected me. From that time on I committed myself to helping improve the lives of individuals who suffer from mental illness and their family members.

(7) Can you foresee any possible conflicts of interests that could arise during your service on the State Council on Mental Health? How would you overcome any possible conflicts of interest?

Since I'm involved with mental health nonprofit agencies there could be a conflict of interest. However, it has not been an issue in the past.
