SUBJECT: GM 664 - State Council on Developmental Disabilities Gubernatorial Nominee Mary Brogan

The State Council on Developmental Disabilities **SUPPORTS GM 664** to confirm the nomination of Mary Brogan for a second term to expire June 30, 2027.
