- Submittal of a report by the three-person review subcommittee to the President, and subsequently to the entire Board.

- Meeting of the President, the Executive Director, and the nominee prior to the scheduled interview of the nominee by the Board.

The HSBA President and the Executive Director met with Ms. Guidry on April 18, 2023 to discuss the subcommittee's findings. On April 19th, Ms. Guidry was interviewed by the HSBA Board of Directors in executive session.

Documentation submitted by Ms. Guidry was reviewed and the references listed were contacted for their personal opinions and observations. The comments and letters received from HSBA members reflected an affirmation of Ms. Guidry in all categories of the HSBA criteria which include:

- Integrity
- Diligence
- Legal knowledge and ability
- Professional experience
- Temperament
- Financial responsibility
- Public service
- Ability to fulfill the responsibilities and duties of the position

Kimberly Guidry, the nominee for the new judicial position on the Intermediate Court of Appeals, is a beneficiary of Hawaii's public education system, having graduated with honors from Kalani High School, the University of Hawaii at Manoa, and the William S. Richardson School of Law. The Nominee has spent her entire legal career in the Department of Attorney General for the State of Hawaii since 2002. She began as a Deputy Attorney General and was subsequently promoted to First Deputy Solicitor General, Supervising Attorney General, and Solicitor General. Ms. Guidry specializes in appellate work and has been involved with many complex and high profile cases, including Red Hill appeals, emergency proclamations, Second Amendment litigation and legislation, reproductive rights, and other constitutional issues. She has also represented Hawaii in multistate amicus briefs, and comment letters on national issues.

As Solicitor General and a senior member of the Attorney General's Appellate Division, the Nominee guides trial staff in the development of litigation strategies that create thorough case records in anticipation of potential appeals. As a valued senior member of the Attorney General's staff, she served on the Department's Appeals and Opinions Review Committee to provide continuing education for deputies, trained deputies on Hawaii Appellate Rules, and drafted "Hawaii Rules of Appellate Procedure Quick Reference Guide" for the legal staff. She also serves on the Judiciary's Hawaii Rules of Appellate Procedure standing committee and is a Bar Examiner for the Hawai'i State Board of Bar Examiners. And for three months in 2006, the Nominee served as a National Association of Attorneys General Supreme Court Fellow in Washington D.C.

HSBA members (including opposing counsel) noted that Ms. Guidry earns the respect of those around her by always respecting their thoughts and opinions, even when she disagrees. She is known as a diligent attorney who has a solid grasp of appellate procedure and is hardworking,

conscientious, responsible, detailed, and a gifted writer. And it was noted that she possesses the wisdom and experience to make good decisions that will ultimately stand the test of time.

After the interview of the nominee, which included dialogue and questioning relating to her background, experiences, and reasons for pursuing the position of Intermediate Court of Appeals Associate Judge, the Board of the Hawaii State Bar Association found Ms. Kimberly T. Guidry to be **QUALIFIED** for the position of an Associate Judge of the Intermediate Court of Appeals.

Dear Chairperson and members:

I am Girard D. Lau, Solicitor General of Hawaii from 2011 to 2016.

I'm testifying to offer my strongest recommendation that Hawaii Solicitor General Kimberly Tsumoto Guidry be confirmed for the position of Associate Judge of the Hawaii Intermediate Court of Appeals.

I know Kimberly extremely well — perhaps more than anyone — in terms of her professional ability, legal skills, work ethic and integrity, and am very familiar with her personal qualities as a person. This is because I worked closely with her as a colleague and/or as her supervisor for 14 years in the Appellate Division of the Hawaii Department of the Attorney General. So I am fully aware of her amazing legal capabilities, and her outstanding character.

First, Kimberly's character: Kimberly has the highest ethical standards and integrity. In my 14 years working closely with her on an often daily basis, I have never known her to do anything improper, or to express thoughts reflecting a selfish, improper, discriminatory, or even marginally unethical viewpoint. Instead, she has conducted herself with the utmost integrity, and with compassion for the less fortunate, and others who may often face societal discrimination. She is also a kind and thoughtful person, who genuinely cares about others.

Second, Kimberly's temperament: Kimberly is always calm and composed when dealing with colleagues and opposing counsel, even when many might become very upset. It is thus very clear to me that were Kimberly to become an ICA judge, she would conduct herself on the bench in a very respectful manner, both to colleagues, and, perhaps most importantly, to the advocates who argue before her. She would never blow up or otherwise try to intimidate counsel, but would, of course, like all judges, expect counsel to conduct themselves appropriately and with proper preparation.

Third, Kimberly's legal abilities: Kimberly is an excellent writer, who expresses herself in writing in a very clear way, that will make understanding her judicial opinions easy, and most useful to the legal community. Kimberly's ability to analyze legal arguments, and assess and critique weak or specious theories, is tremendous. She can cogently scrutinize competing legal arguments and theories, and reach a well-reasoned conclusion, and support that conclusion with compelling analysis and case precedent.

She has extensive knowledge of a broad range of caselaw critical to appellate decisionmaking. She is also open-minded and willing to modify her initial position when presented with solid reasoning demanding a different conclusion. I know this as I reviewed virtually all of her written work, including legal briefs, when I was her supervisor.

She is also brilliant in orally discussing legal issues, and engaging in legal debate (which ICA judges do at oral argument), as I spent many hours doing that with her over the years, both as a colleague and as her supervisor. I have witnessed her sharp legal mind in action on numerous occasions, including at Hawaii Supreme Court oral arguments.

Because of her stellar legal ability, Kimberly is uniquely suited to becoming a very effective judge and an impressive asset to the ICA's legal stature. She would certainly become a highly respected jurist were she fortunate enough to become an ICA judge.

In summary, someone possessing all of the above critical qualities for being an excellent ICA judge, as Kimberly does, is a rarity. Accordingly, I offer the strongest recommendation that Kimberly be confirmed to this ICA judgeship.

Thank you for taking the time to consider this sincere, but enthusiastic, recommendation.

I am submitting this letter in support of the nomination of Kimberly Tsumoto Guidry for Associate Judge of the Hawai'i Intermediate Court of Appeals.

In the interest of full disclosure, I am currently serving as the First Deputy Solicitor General in the Appellate Division of the Department of the Attorney General. Consequently, I am Ms. Guidry's principal deputy in her capacity as Solicitor General and supervisor of the Appellate Division. However, I write this letter not as her subordinate but as someone who has worked closely with her for the last 12 years. Because I have worked with her for so long, I am very familiar with her abilities and character. I can say without a doubt that she possesses abilities and character of the highest level.

Due to the nature our work in the Appellate Division, Ms. Guidry is an expert in appellate practice. She has handled many complex and high-profile cases, including constitutional cases. She has also been involved in the legislative process, due to the role of the Department of the Attorney General in that process. As Solicitor General, she has also been serving as the supervisor of the Appellate Division and therefore has experience managing other attorneys and staff.

I have seen Ms. Guidry lead the Appellate Division through some very difficult times. This Division is ordinarily staffed by six attorneys and two legal assistants. However, at one point, due to multiple retirements, transfers, and personal emergencies, our Division was down to two attorneys (Ms. Guidry and myself) and no active legal assistants. That was not an easy time, to put it mildly. However, since then, and through Ms. Guidry's hard work, the Appellate Division has grown to become what I regard as a group containing among the best lawyers in Hawai'i. Our Division has handled many major issues for the State, including the Red Hill appeals, emergency proclamations, Second Amendment litigation and legislation, and reproductive rights. We have also represented Hawai'i in multistate amicus briefs and comment letters on national issues and in multistate lawsuits filed against the prior presidential administration. I believe the Appellate Division is critical to the mission of the Department of the Attorney General, and Ms. Guidry has played an indispensable role in leading our Division over the last few years. Regarding specific cases, Ms. Guidry led the State's defense in *League of Women Voters* of Honolulu v. State, 150 Hawai'i 182, 499 P.3d 382 (2012), which addressed the constitutionality of the Legislature's procedures in enacting legislation. Ms. Guidry also played a major role in the Department's subsequent efforts to explain the requirements of that decision to legislators. See A.G. Opinion No. 22-01.

I believe that Ms. Guidry also has the judgment and temperament to be a fine appellate judge. When dealing with complex cases, it is easy to get lost in the legal doctrines and lose sight of the big picture, or even common sense. But having worked with Ms. Guidry for many years, I believe that, fundamentally, she possesses the wisdom and experience to make good decisions that will ultimately stand the test of time.

Please note that the opinions expressed here are made in my personal capacity and nothing in this letter should be interpreted as reflecting the position of the Department of the Attorney General or the Appellate Division.
