Chair Yamashita, Vice Chair Kitagawa, and Members of the Committee:

The Department of Public Safety (PSD) supports House Bill (HB) 1131, HD1 which appropriates funding to the University of Hawaii Thompson School of Social Work and Public Health to conduct a comparative study of all programs offered to persons incarcerated at correctional facilities in the State for the purpose of identifying gaps in programming offered to female inmates.

PSD believes a comparative study of correctional programming to include any proposed legislation and funding will assist our efforts to create successful pathways for offenders as they re-enter the community. To maintain the integrity and validity of a study of programming for incarcerated men and women for the purpose of identifying gaps in programming offered to female inmates, PSD strongly supports the inclusion of the Interagency Council on Intermediate Sanctions (ICIS) and its Correctional Program Checklist Committee (CPC) to review documents, observe program components, interactions, and interview staff and participants in order to evaluate effective programming practices in the delivery of quality programs offered to persons incarcerated at correctional facilities in the State. addressing areas in need of improvement and any potential sources of funding to facilitate parity in the range and quality of programming that is offered to female and male inmates in the State shall require PSD approval and a competitive Request for Proposal (RFP).

H.B. 1131 also appropriates necessary funds to facilitate accomplishing the purpose of this bill.

# STRONG SUPPORT FOR SB711 RELATING TO GENDER PARITY IN PROGRAMS FOR INCARCERATED WOMEN.

Women's Prison Project strongly supports HB1131 which would determine the State's compliance with Section 367D-1 of Hawaii Revised Statutes (HRS), which requires that "incarcerated women shall be provided a range and quality of programming substantially equivalent to the range and quality of programming offered to male persons who are similarly situated." To date there are no reports that verify such parity.

The statute further states that programming should specifically address "the psychosocial developmental needs of women". Programming is required to be "substantially equivalent to...." but not necessarily identical to programming for men.

HB1131 would appropriate \$120,000 for a study to provide a comprehensive view of programming across Hawaii's corrections system, looking especially at gaps in programming for incarcerated women. The study will highlight the specific rehabilitation needs of women which may or may not currently be met.

In order to evaluate the current level of parity for women, it will be necessary to identify all programing offered to incarcerated men as well as that offered to women. The information gained in this process will provide a valuable tool for future planning, not only for women but for all incarcerated persons as Hawaii moves toward the rehabilitative system implied by the new department designation of Department of Corrections and Rehabilitation. The study will highlight the specific rehabilitation needs of women which may or may not currently be met.

Effective planning requires a comprehensive analysis of current programming, a knowledge of best practices, and identification of key programming options in order to achieve the goal of

reducing recidivism. We cannot continue to accept a 50% recidivism rate for women leaving Women's Community Correctional Center. We urge the legislature to mandate and fully fund the proposed parity study
