The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA <u>SUPPORTS</u> House Bill No. 1248, House Draft 1, RELATING TO SUPPLEMENTAL NUTRITION ASSITANCE PROGRAM INCENTIVES.

By way of background, the HPCA represents Hawaii's Federally Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines to over 150,000 patients each year who live in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare.

This bill, as received by your Committee, would appropriate an unspecified amounts of general funds for fiscal years 2023-2024, and 2023-2025, to be expended by the Department of Agriculture, for the continued administration of the Hawaii Healthy Food Incentive Program and to provide matching funds to beneficiaries who participate in the Supplemental Nutrition Assistance Program (SNAP).

This bill would take effect on June 30, 3000.

SNAP, formally known as the "Food Stamps Program", is the largest federal food assistance program that is currently in operation. It provides food-purchasing assistance for low- and no-income people. SNAP provided assistance to approximately 40 million persons in 2018, at an expenditure of \$57.1 billion. Approximately 9.2% of American households received SNAP benefits at some point during 2017, with approximately 16.7 of all children living in households receiving SNAP benefits.

Founded during the height of the Great Depression, SNAP is the cornerstone of our national social safety net. It is intended to prevent mass starvation precipitated from unemployment and homelessness. The program was also seen as a way of helping the poor while boosting the economy and ensuring that America's farmers would obtain a fair price for their labors by allowing government to purchase and distribute excess goods in time of crisis.

The COVID-19 Pandemic demonstrated how food scarcity and poverty threatened the health and welfare of our citizens in times of dire crisis. With so many people unemployed, entire families struggled to put food on the table on a consistent basis. Lines at the food bank and food drives stretched for miles and people waited for hours to receive surplus food.

The HPCA has strongly endorsed this Program in previous years and we continue to urge your support. Additional SNAP benefits for a recipient can mean the difference between having to decide whether someone's last amount of cash will go for food or rent or medications or other necessities.

I am in strong support of bill HB1248 and the appropriation of funds for the continued administration of the Hawai'i healthy food incentive program, otherwise known as DA BUX Double Up Food Bucks, or DA BUX.

By way of introduction, my name is Emily Emmons. I am the co-founder and executive director of Hoʻōla Veteran Services 501c3 dba Hoʻōla Farms, established on Hawaiʻi Island in 2015 to provide natural agriculture educational training and hands-on experiences for military veterans, their families, and the community in hopes of creating a more sustainable community for all. Over the last two years Hoʻōla Farms has expanded services to adopt a full agribusiness incubator model, with programs including Hilo Food Hub and Hawaiʻi Farm to Car online farmers market.

In April 2022, we started offering SNAP/EBT to our Hawaii Farm to Car customers and have seening a steady increase in new customers and repeat orders, with 556 unique SNAP customers served in the first year. We also saw an increase in the Market's average dollar amount per order from \$41 per order to \$70 per order, with SNAP/EBT sales totalling \$40,047.24 in 2022. This expanded customer base and additional revenue went directly back to the farmers, not only increasing revenues but also providing stability in the market for farmers to scale up their operations to support the increasing demand.

Hawai'i Farm to Car has recently been added to the DaBux list of East Hawai'i retailers and in the first month we have increased from 15 SNAP customers per week to 30 SNAP customers per week, doubling SNAP dollars spent compared to the Januaray 2023, and we expect the demand to continue to grow over the next year.

This State investment is critical to the long-term sustainability of DA BUX and its ability to provide positive, lasting impact both economically and for the well-being of individuals across the state.

I am in strong support of bill HB1248 and the appropriation of funds for the continued administration of the Hawai'i healthy food incentive program, otherwise known as DA BUX Double Up Food Bucks, or DA BUX.

DA BUX benefits the state's food system through three different ways. First, DA BUX offers discounts on Hawai'i grown fruits and vegetables to low-income recipients of the Supplemental Nutrition Assistance Program, allowing them to purchase more, healthy food. Second, DA BUX helps farmers increase their customer base and compete with imported produce. And third, DA BUX supports the local economy, generating increased revenue for 57 participating food retailers across 100+ statewide locations.

DA BUX has proven to be beneficial for Hawai'i's economy. According to a study conducted by Colorado State University, each program dollar used to incentivize local produce contributes \$2.10 to Hawai'i's economy. Additionally, if DA BUX was further scaled to food retail locations statewide, the potential economic contribution would be \$14-\$22 million in one year.

Furthermore, a \$3 million State investment will serve as significant match funds needed to unlock federal grant dollars from the USDA Gus Schumacher Nutrition Incentive Program (GusNIP). As the GusNIP only accepts proposals that have secured 100% non-federal matching funds, a State investment will strengthen the program's FY '23 application.

State investment is critical to the long-term sustainability of DA BUX and its ability to provide positive, lasting impact both for the economy and the well-being of individuals across the state.



My name is Michael Robinson, and I am the Vice President of Government Relations & Community Affairs at Hawai'i Pacific Health. Hawai'i Pacific Health is a not-for-profit health care system comprised of its four medical centers – Kapi'olani, Pali Momi, Straub and Wilcox and over 70 locations statewide with a mission of creating a healthier Hawai'i.

HPH writes in SUPPORT of HB 1248, HD1 which appropriates funds to the Department of Agriculture for the continued administration of the Hawai'i healthy food incentive program, and to provide matching funds to beneficiaries who participate in the supplemental nutrition assistance program (SNAP).

HPH recognizes the strong connection between access to healthy foods with health and wellness. Adults who eat a healthy diet live longer and have a lower risk of obesity, heart disease, type 2 diabetes, and certain cancers. Healthy eating can help people with chronic diseases manage these conditions and avoid complications. However, many low income families continue to struggle to put food on the table.

HPH has supported the Double Up food bucks program since 2019 to both foster strengthening local food systems and allow SNAP recipients to access good nutrition. The program has been successful in encouraging SNAP recipients to make healthy food choices. Fresh fruits and vegetables are an integral part of a healthy diet and central to the prevention of obesity and chronic disease. While every community should have access to fresh and healthy dietary options, the high cost of fresh produce often makes that difficult. This challenge is felt acutely by participants in the federal supplemental nutrition assistance program, a low-income population that struggles to afford healthy food. The double up food bucks program is a viable model that supports local farmers, helps low-income families that receive double the purchasing power for healthy, Hawaii-grown produce, and benefits Hawaii by keeping dollars in the local economy.

Food security is a critical issue in Hawai'i, where one in six residents lacks comprehensive access to healthy, nutritious food. SNAP is one of our most important anti-hunger programs, offering choice and healthy options for families who need extra support putting food on the table. We strongly support DA BUX, which doubles the purchasing power of SNAP when it is used for locally produced food.

- **DA BUX increases consumer purchasing power.** Locally grown produce is often more expensive than imported items. DA BUX stretches dollars farther and makes it possible for more people to choose local.

Dear Chair Gabbard, Vice Chair Richards, and members of the Committee:

Thank you for the opportunity to submit testimony in support for **H.B. 1248**, which would provide matching funds to appropriate funds to the Hawai'i Department of Agriculture (DOA) for the continued administration of the Hawai'i healthy food incentive program and beneficiaries who participate in the supplemental nutrition assistance program (SNAP).

SNAP is a proven economic stimulus. In fact, the <u>USDA estimates</u> that every dollar in SNAP generates an additional \$0.54 in economic activity. In 2022, nearly 170,000 Hawai'i residents drew down over \$900 million in federal SNAP funds to purchase food—an estimated \$1.4 billion dollar investment in Hawai'i's food system after applying the economic multiplier.

While SNAP is an important program for ensuring the food security of low-income Hawai'i households, the individual household benefit is often still not enough to afford fresh fruits and vegetables. This results in most of these economic stimulus funds leaving the islands—right into the pockets of major mainland food companies, rather than getting recirculated locally into our local agriculture industry.

SNAP incentives like those proposed in H.B. 1248 address this concern by providing an additional subsidy for SNAP users when they purchase local fruits and vegetables. The federal program that funds this incentive requires a one-to-one match, meaning that every dollar the state invests will be matched by federal funding. *Therefore, a \$3 million investment by the state would be doubled with matching federal funds. Factoring in the \$1.54 multiplier mentioned earlier would ultimately result in \$9.24M million in economic impact.* Passing this bill would be an impact investment for the State, channeling much-needed capital into local businesses and farms.

Hawai'i's existing SNAP incentive program, known as DA BUX, has already been enormously successful and popular among SNAP users, retailers, and farmers alike. According to the latest program outcomes report, DA BUX has already directly supported 470 farm producers, eight distributors, and increased local produce sales by 531% at farm-direct retailers.

SNAP incentives are a win for everyone—families, farmers and local businesses. There is no downside. Thank you for the opportunity to provide testimony.

Aloha Chair Gabbard, Vice Chair Richards, and Members of the Committee,

The Kūpuna Caucus of the Democratic Party of Hawai'i has a membership of more than 2,000 politically active and aware seniors and we strongly support all assistance to the SNAP program in Hawaii.

The ever rising cost of all food in Hawaii makes this state one of the most challenging for people suffering food insecurity. Ironically, local produce is often just as costly, or more costly, than produce imported from the mainland because the cost to local growers for being farmers is prohibitive.

The DA BUX program would be and should be extremely helpful to people who want to buy local produce. The Kūpuna Caucus supports that concept. However, as a Kūpuna who relies on the SNAP program for food, my personal experiences have been disappointing. My first experiences with the card were that it was unusable. There was a lack of participating supermarkets and other sources of local produce, like farmers markets which made it useless. I gave up carrying my Da Bux card within months of receiving. This bill says the program has improved and expanded however I never received up dated information about the card or any expanded services which might be available

A program like this is absolutely necessary, but the structure may need to be changed. I was able to buy more local produce with the extra \$95 a month we received during COVID than was ever possible using Da Bux card.

The Kūpuna Caucus supports the program but we ask the departments in charge to reexamine the way it functions so that it may better serve its purpose.

### American Heart Association testimony in SUPPORT of HB 1248, HD1, "Relating to the Supplemental Nutrition Assistance Program Incentives"

The American Heart Association strongly supports HB 1248, HD1 and asks that the legislature fully fund the \$3 million, two-year funding request.

For more than 50 years, the Supplemental Nutrition Assistance Program (SNAP – formerly Food Stamps) has been vital in addressing food insecurity and nutrition in the United States. It has an impact on health, educational attainment and economic self-sufficiency. The program helps more than 45 million Americans struggling through underemployment and low or stagnant wages. The majority of benefits go to households with children, older adults or those with disabilities.

For more than a decade, SNAP nutrition incentive programs across the country like Hawaii's DA BUX program have existed to reduce hunger and improve nutrition among low-income families while also supporting local agriculture and the economy. The DA BUX program works by providing matching dollars to SNAP recipients to purchase additional fresh fruits and vegetables at participating retailers and farmers markets.

DA BUX directly addresses nutrition insecurity by helping families stretch their food dollars and incentivizing them to buy healthier options. The program helps families teach their children healthy behaviors, establishing lifelong habits that will support their overall health and wellness. Roughly half of all SNAP recipients have children in their homes. In addition, DA BUX acts as a catalyst for the local economy. Farmers and retailers alike benefit from increased sales of local produce.

The COVID-19 pandemic has exacerbated a problem that has long existed in Hawaii – nutrition insecurity, or a household's inability to provide enough nutritious food for every person to live an active, healthy life. Today, local families are finding it harder than ever to put nutritious food on the table. According to data from Feeding America, the number of Hawaii residents dealing with food insecurity has grown by 51 percent since 2019. In addition, about 81,000 keiki across the state are food insecure this year.

Food insecurity and poor nutrition remain problems for millions of American households. Research shows that SNAP benefits are often not adequate to last a family the entire month. A 2016 report by the Food Research and Action Center summarized the important role SNAP plays in addressing food insecurity. Importantly, the majority of SNAP recipients who are eligible for work do so while on the program, underscoring that many recipients are using the program to overcome underemployment or temporary job loss.

Although diet quality has been steadily improving in the U.S. during the past two decades, overall dietary quality is still poor. Most significantly, there is a widening gap associated with education and income. Despite the important role SNAP plays in

addressing hunger, additional data indicate that SNAP recipients have worse diet quality than income-eligible non-participants.

The DA BUX program is already successfully in place at a number of retail and farmers market locations across the state. However, current funding does not allow for expansion of the program to all geographic areas of the state meaning that not all in need have access to its benefits. The proposed funding would allow the DA BUX program to expand more broadly across the state, reaching thousands of additional residents in need, and to sustain existing programs. HB 1248, HD1 would also allow the state to draw down matching federal funds doubling the health and economic benefits to Hawaii.



Mahalo for this opportunity to provide testimony in strong support for HB1248, "Relating to Supplemental Nutrition Assistance Incentives," on behalf of Farm Link Hawai'i (FLH). We encourage you to support the appropriation of funds for the continued administration of the Hawai'i healthy food incentive program, otherwise known as DA BUX Double Up Food Bucks, or DA BUX. According to a study conducted by Colorado State University, each program dollar used to incentivize the purchase of local produce contributes \$2.10 to Hawai'i's economy. DA BUX benefits Hawai'i's food system in three vital ways:

- 1. Offers discounts on Hawai'i grown fruits and vegetables to low-income SNAP recipients, allowing them to purchase more healthy food
- 2. Empowers farmers compete with lower cost imported produce and increase their sales
- 3. Supports the local economy, generating increased revenue for participating retailers

Farm Link's mission is to create a thriving, equitable local food system by empowering local farmers and improving access to good local food. We work with over 170 Hawai'i farmers, ranchers, and food makers, to serve more than 1,000 customers with over 500 local products. Over 18% of our revenue is derived from customers using Supplemental Nutrition Assistance Program (SNAP-EBT) and DA BUX to purchase their groceries. Last year FLH saw transactions associated with the DA BUX program grow by over 300%. We see this as a clear sign that DA BUX is motivating families to purchase and consume more healthy produce, and providing a steady market for Hawai'i farmers.

State investment is critical to the long-term sustainability of DA BUX and its ability to provide positive, lasting economic and well-being impact. A \$3 million State investment will serve as significant match funds to unlock federal grant dollars from the USDA Gus Schumacher Nutrition Incentive Program (GusNIP). As the GusNIP only accepts proposals that secure 100% non-federal matching funds, a State investment is critical to the program's FY '23 GusNIP application.

The Obesity Prevention Task Force (OPTF), a program of the Hawai'i Public Health Institute<sup>i</sup> (HIPHI), is in **Strong Support of HB1248 HD1**, which provides continued funding for the Hawai'i Healthy Food Incentive Program.

#### Double Up Food Bucks is a triple win for families, farmers, and the local economy.

The Hawai'i Healthy Food incentive program, also known as DA BUX, provides a dollar-for-dollar match on locally produced fresh fruits and vegetables for SNAP recipients. Through this program, SNAP recipients can bring home healthy food, local farmers gain new customers and increased income, and more money goes into and grows our local economy.

Incentivizing SNAP dollars for fresh fruits and vegetables stretches food dollars for families, especially with increasing food costs. Furthermore, the doubling effect that DA BUX has on SNAP dollars gives families more room in their budgets for other necessary expenses.

#### Double Up Food Bucks demand has risen significantly over the last several years.

Year after year, this program has grown its impact making a significant impact on SNAP recipients. In 2019, SNAP shoppers spent \$87,359 through the DA BUX program; by 2022, SNAP shoppers spent \$2,275,460 through the DA BUX<sup>ii</sup>. That money has brought healthy foods to homes while positively impacting our local economy.

#### <u>Double Up Food Bucks provides a strong return on investment.</u>

SNAP is proven to stimulate the economy by being an economic multiplier. For every SNAP dollar spent, it generates \$1.79 in economic activity. These dollars ripple out throughout the supply chain, supporting farmers, retailers, and food distributor employees; these people, in turn, spend their dollars to help support economic activity further and so on. If the state provides \$3 million in funding for this program, the federal

government could provide up to an additional \$3M of matching funds. This \$6M would result in over \$9.9M of total economic activity. In other words, the \$3M investment has a return of over 230%.

#### Health and food security are positively impacted.

Double Up Food Bucks' focus on locally grown produce helps to bring healthy foods to homes and supports the local agricultural industry. Studies have found that a lack of food security is associated with diet-related chronic diseases such as diabetes and high blood pressure<sup>iii</sup>. Supporting local agriculture also aligns with the renewed calls to increase local food production and decrease Hawai'i's dependence on imported goods for a more sustainable and resilient food system.

#### A \$3 million investment can help expand the program to more stores.

The Double Up program has seen significant growth. It started with KTA in Hawai'i County and is now accessible statewide through Times, KTA, Foodland, and participating farmers' markets. These stores are locally based and operated, ensuring the economic impact is amplified. There are still ways for the program to grow its impact.

The \$3M will increase the program's reach and participation by engaging more people through educational campaigns in areas where there has been stalled growth, as well as provide the ability to engage more retail outlets that were unable to participate due to a limit of SNAP funding for participants.

Double Up Food Bucks is a triple win for health, agriculture, and the local economy and is a lifeline for many during the pandemic. We strongly support this measure and respectfully ask you to pass HB1248 HD1.

Especially with high inflation and the most expensive groceries in the nation,<sup>3</sup> it is nearly impossible for the low-income families in Hawai'i who qualify for SNAP to afford to buy healthy food, such as fresh fruits and vegetables.

That's where DA BUX comes in. It is designed to help low-income families afford fresh produce, by doubling the value of their SNAP benefits when they purchase Hawai'i grown fruits and vegetables.

DA BUX truly is a triple-win for our state. First, it helps families afford fresh produce, which benefits their health and well-being. Second, it helps local farmers by increasing their sales. And third, it helps our local food stores and markets by bringing more dollars to them and keeping those dollars in the local economy.

SNAP shoppers' local produce purchases at DA BUX grocery stores nearly tripled in January 2022 compared to 2019, and at DA BUX farm direct retailers those sales were more than five times larger. In addition, every \$1 spent on DA BUX is estimated to create \$2.30 in local economic activity.

**Ulupono strongly supports HB 1248 HD1**, which appropriates funds to the State Department of Agriculture (DOA) for the continued administration of the Hawai'i Healthy Food Incentive Program and to provide matching funds to beneficiaries who participate in the supplemental nutrition assistance program.

Ulupono strongly supports the Hawai'i Healthy Food Incentive Program within the DOA. The "DA BUX" Double Up Food Bucks Program, administered by The Food Basket, Hawai'i Island's food bank, is a triple-win solution for our communities as SNAP-eligible recipients double their spending power at point of purchase with healthy local produce, local farmers are able to expand their markets, and all money spent is kept right here in our state. In addition, this program leverages federal funding at a 1:1 match.

From 2020-2021, DA BUX has supported more than 470 farm producers and eight distributors through farm product sales. With rising inflation and Hawai'i's high cost of living, SNAP participation and benefits continue to climb since 2019 levels.<sup>1</sup> These numbers substantiate the need to support our local community as food insecurity continues to increase.

We are hopeful that the State can consider a \$3 million appropriation, per year, for the DOA program to support the continued efforts of DA BUX. A \$3 million investment by the State would receive a direct match of \$3 million in federal funding. Furthermore, our analysis shows that with that level of state funding in place, the potential economic impact created by DA BUX in Hawai'i reaches nearly \$19 million.

### **DA BUX Double Up Food Bucks provides a Triple-Win**

HAWAI'I IMPORTS APPROXIMATELY 85-90% of its food and has food costs that are 91% higher than the national average. Dependence on food imports threatens the sustainability of food producers throughout the islands and places the entire population directly at risk of food shortages in the event of pandemics, natural disasters, and economic disruptions. Furthermore, with the highest cost of living in the nation, Hawai'i is challenged with growing food costs and food insecurity, and 12% of its population receives Supplemental Nutrition Assistance Program (SNAP) in 2022.

#### THE PROBLEM


Overall, Hawai'i faces an estimated \$83 million in annual costs related to food insecurity and hunger. Due to the COVID-19 pandemic and the rising inflation, Hawai'i households are facing increasing food costs. Compared to the rest of the nation, Hawai'i households spend the highest percentage of their annual budget on food. This is compounded with the rising inflation that has increased food prices and overall cost of living in Hawai'i by 6.6% and 7.4%, respectively. Increasing food prices reinforces many residents' reliance on cheaper, less healthy fast food options that have long-range impacts on health and wellbeing. This situation creates a significant need to help feed low income families AND support local agricultural food producers.


#### Monthly Average of Individual SNAP Recipients in Hawai'i

An appropriation of up to \$3 million in state funds will bring in additional federal funds to sustain, expand and extend the statewide DA BUX Double Up Food Bucks program. Given the broad benefits of DA BUX for our state, it is imperative to secure sustained funding for DA BUX and ensure it is a staple service providing economic relief to SNAP households and directly supporting local agricultural food producers across the state. Based on the projected spend down rate, current funding of the DA BUX program will only last through August 2024.

Over the course of the pandemic, DA BUX has become a critical service for low-income SNAP beneficiaries struggling with economic hardship and food insecurity. There has been significant growth and demand for the program due to the increase in SNAP participation and participating DA BUX retail locations across the state.

- From 2020 through 2021, DA BUX supported 470 farm producers and 8 distributors by incentivizing the sale of their farm products sold at participating farm direct retailers.

- DA BUX gives farmers the opportunity to feed local residents (rather than exporting product to the mainland) and to increase production towards a self-sufficient local food supply for the state.


### **More Impact for State 'BUX'**

Due to rising inflation and higher cost of living, SNAP participation and SNAP benefits in Hawai'i continue to be significantly higher compared to 2019 levels.


- 8th highest poverty rate (10.5% of the population living at or below the poverty line)
- 9% increase in the number of individuals in Hawai'i receiving SNAP benefits
- 100% increase in the annual total amount of SNAP benefits paid in Hawai'i
- 26x increase the annual total of DA BUX discounts issued to SNAP shoppers

Historically, the DA BUX program has been primarily funded by Federal grants and philanthropic/private funding (representing almost all of total program funds). To date, the State of Hawaii has only provided \$94,000 in General Funds, and allocated \$500,000 in Federal CARES Act funds to the program.

Founded in 1994 by Hawai`i's community health centers, AlohaCare is a community-rooted, non-profit health plan serving over 80,000 Medicaid and dual-eligible health plan members on all islands. Approximately half of our membership are keiki. We are Hawai`i's only health plan exclusively dedicated to serving Medicaid beneficiaries. Our mission is to serve individuals and communities in the true spirit of aloha by ensuring and advocating for access to quality health care for all. We believe that health is about supporting whole-person care.

AlohaCare's commitment to whole person care includes addressing a variety of social determinants of health, including housing, economic stability, and nutrition among other factors. We understand that without access to affordable healthy food, the health and well-being of our members is negatively impacted. For example, researchers from the Centers for Disease Control and Prevention found that food insecurity is associated with obesity among US adults in Hawai`i and 11 other states.<sup>1</sup>

AlohaCare has provided grant funding to Kokua Kalihi Valley and others to support this program, and we endorse continued State investment. The Hawai'i Healthy Food Incentive Program is an innovative and successful solution, which supports local farmers, low-income families who receive double the purchasing power for Hawai'i-grown fresh fruits and vegetables, and our entire community by keeping dollars in the local economy. This program is particularly important during this time of rising costs for food among other necessities.

Aloha Chair Gabbard, Vice Chair Richards, and Members of the Senate Agriculture and Environment Committee,

We are writing to voice our strong support of HB1248 and the appropriation of funds for the continued administration of the Hawai'i Healthy Food Incentive Program, otherwise known as DA BUX Double Up Food Bucks, or DA BUX.

My name is Harmonee Williams, and I am the Executive Director of the Hawai'i Good Food Alliance (HGFA). Prior to joining HGFA staff, I served as the Executive Director of Sust'āinable Molokai, which is a founding organizational partner of HGFA. The other founding organizations are listed below. HGFA is a 501(c)(3) corporation formed by a statewide collaboration of organizations that are engaged in the production and distribution of food with the goal of rebuilding thriving community food systems. HGFA is a cross-sector network of food producers, food hubs, food banks, farmers markets, and healthcare providers from each major Hawaiian island. Our mission is that we join together—with a sense of urgency—to raise community voice and support one another in the belief that each and every person in Hawai'i can share in healthy, locally produced food.

DA BUX benefits the state's food system through three different ways. First, DA BUX offers a 50% discount on Hawai'i grown fruits and vegetables to low-income recipients of the SNAP program (formerly known as food stamps), allowing them to purchase more, healthy food. Second, DA BUX helps farmers increase their customer base and compete with imported produce. And third, DA BUX supports the local economy, generating increased revenue for the participating food retailers across 100+ statewide locations. Several of our member organizations offer DA BUX through their retail operations, allowing them to offer affordable local produce to all of their SNAP customers.

A \$3 million State investment will serve as significant match funds needed to unlock federal grant dollars from the USDA Gus Schumacher Nutrition Incentive Program (GusNIP). As the GusNIP only accepts proposals that secure 100% non-federal matching funds, a State investment will strengthen the program's FY '23 GusNIP application. State investment is critical to the long-term sustainability of DA BUX and its ability to provide positive, lasting impact both for the economy and the well-being of individuals across the state.

# DA BUX helps local producers thrive and sets beginning farmers up for success.

In FY21, DA BUX supported 470 farm producers and 8 distributors statewide by incentivizing the sale of their farm products sold at participating farm direct retailers. This support resulted in a 531% average increase in local produce sales at participating retailers. # Nutrition incentive programs are a lifeline to Hawai'i's struggling families.

The ending of the public health emergency and SNAP emergency allotments has resulted in *more than 83,000 of Hawai'i's low-income households* experiencing the greatest SNAP benefit cliff in history. With SNAP participating households losing at least \$95 per month (with some of our most vulnerable losing up to \$238), DA BUX has become even more vital to improve access to healthy food for these communities as their purchasing power decreases. Our emergency food system alone cannot fill this gap and meet the need.

# DA BUX sustainability requires state investment, which the federal government can match.

A \$3 million state investment will provide significant match funds required to unlock federal grant dollars from the USDA Gus Schumacher Nutrition Incentive Program (GusNIP), which the state applicant—The Food Basket—has successfully applied for and received previously. With an economic multiplier of 2.3 for every \$1 spent in Hawai'i on incentives, a \$3M investment by the state will result in \$12.6M generated in Hawai'i's local economy.<sup>4</sup>

Aloha Chair Gabbard and Vice Chair Richards,

We are in strong support of HB1248 HD1 and the appropriation of funds for the continued administration of the Hawai'i Healthy Food Incentive Program, otherwise known as DA BUX Double Up Food Bucks, or DA BUX.

In keeping with The Food Basket's (TFB) overarching mission to "end hunger", we are the statewide administrator for DA BUX. TFB established DA BUX as a statewide program upon receiving a \$985 K federal grant through the USDA Gus Schumacher Nutrition Incentive Program (GusNIP). Additionally, we secured the 100% non-federal matching funds that GusNIP requires. We scaled the program in 2021 after receiving two additional GusNIP awards totaling \$7.6 MM in federal dollars. Today, TFB administers DA BUX at 57 food retailers across 100+ locations statewide, including grocery stores, farmers markets and food hubs. DA BUX partner retailers continue to offer 50% discounts on Hawai'i grown fruits and vegetables solely to low-income customers paying with SNAP food dollars (formerly known as food stamps).

Philanthropy has largely carried the weight of our GusNIP match needs over the years; however, we cannot expect philanthropy to meet this need over the long term. We are humbly requesting the State to invest \$3 MM per year in DA BUX to support program sustainability and continuous affordable healthy food access to SNAP recipients. Furthermore, a State commitment will be leveraged in our FY '23 GusNIP application to

unlock \$3MM in federal funds to meet the grant's requirement of a 100% non-federal match.

**EXECUTIVE DIRECTOR** 

While a wide range of financial support and programs were available during the pandemic, Hawai'i's low-income residents are perhaps now more in dire need of this support as pandemic relief wanes and inflation rates have soared above historical averages. Sustained high participation in SNAP above pre-pandemic levels and climbing food insecurity in Hawai'i are indicative of the widespread economic hardship residents continue to face. The Food Basket remains steadfast in our commitment to ensuring DA BUX savings for local fruits and vegetables will be continuously available for these households.

Please accept this letter in support of HB 1248, relating to the appropriation of funds for the continued administration of the Healthy Hawaii Food Incentive Program, otherwise knowns ad DA BUX Double-Up Food Bucks, or more simply, DA BUX.

DA BUX benefits the state's food system through three different ways. First, DA BUX offers discounts on Hawaii grown fruits and vegetables to low-income recipients of the Supplemental Nutrition Assistance Program, allowing them to purchase more, healthy food. Second, DA BUX helps farmers increase their customer base and compete with imported produce. And third, DA BUX supports the local economy, generating increased revenue for 57 participating food retailers across 100+ statewide locations.

Since launching DA BUX in Sept 2017, KTA has seen transactions associated with the DA BUX program significantly increase at our seven locations. We see this as a positive sign that DA BUX is motivating families to purchase and consume more healthy fruits and vegetables and that this increased demand will drive increases in agricultural production for the state.

DA BUX has proven to be beneficial for Hawai'i's economy. According to a study conducted by Colorado State University, each program dollar used to incentivize the purchase of local produce contributes approximately \$2.10 to Hawai'i's economy. Additionally, if DA BUX was further scaled to food retail locations statewide, the potential economic contribution would be \$14-\$22 million in one year.

A \$3 million State investment in this program would serve as a significant "matching fund" needed to unlock federal grant dollars from the USDA Gus Schumacher Nutrition Incentive Program (GusNIP). As the GusNIP only accepts proposals that secure 100% non-federal matching funds, a State investment will strengthen the program's FY '23 GusNIP application.

State investment is critical to the long-term sustainability of DA BUX and its ability to provide positive, lasting impact both economically and for the well-being of individuals across the state.

Chair Gabbard, Vice Chair Richards, and committee members, thank you for this opportunity to provide testimony on HB 1248, HD1, which appropriates funds to Department of Agriculture for the continued administration of the Hawaii healthy food incentive program and to provide matching funds to beneficiaries who participate in the supplemental nutrition assistance program.

# Kaiser Permanente Hawai'i SUPPORTS HB 1248, HD1.

Kaiser Permanente Hawai'i is one of the nation's largest not-for-profit health plans, serving 12.6 million members nationwide, and more than 269,000 members in Hawai'i. In Hawai'i, more than 4,200 dedicated employees and more than 650 Hawai'i Permanente Medical Group physicians and advance practice providers work in our integrated health system to provide our members coordinated care and coverage. Kaiser Permanente Hawai'i has more than 20+ medical facilities, including our award-winning Moanalua Medical Center. We continue to provide high-quality coordinated care for our members and deliver on our commitment to improve the health of our members and the 1.4 million people living in the communities we serve.

Food insecurity and poor nutrition remain problems for many of our residents. Research shows that SNAP benefits are often not adequate to last a family the entire month. SNAP recipients who are eligible for work do so while on the program, underscoring that many recipients are using the program to overcome underemployment or temporary job loss.

Addressing food insecurity is a critical focus area for Kaiser Permanente. Kaiser Permanente Hawai'i supports policies that ensure all Hawaii residents have access to affordable, high-quality health care. Further, Kaiser Permanente supports "whole-person care," including the provision of access to services and resources that address beneficiaries' physical health, mental health and social needs. Food security means that all people, at all times, have physical, social, and economic



access to sufficient, safe, and nutritious food that meets their food preferences and dietary needs for an active and healthy lifestyle.

To this end, Kaiser Permanente took action to increase enrollment in SNAP, the Supplemental Nutrition Assistance Program. Using a national text-based outreach campaign to our members, we helped 95,000 people apply for the program. We also established innovative partnerships between health care systems and the public sector that identify families who may be eligible for SNAP to encourage enrollment.

We've piloted interventions using medically tailored meals to help people recuperate better at home, and partnered with Produce Rx, to help patients who have diabetes access fresh produce. Aloha Representatives,

As an individual and long-time consultant in the public health sector, I am writing to urge strong support for the DA BUX program. DA BUX partners with food retailers across the state to make Hawai'i grown fruits and vegetables more affordable for low-income recipients of federal food benefits from the Supplemental Nutrition Assistance Program (SNAP). This program is a "triple win" for Hawai'i: Low-income SNAP households are able to afford more healthy local produce; local farmers increase their sales to food retailers; and more federal SNAP dollars stay circulating in our state's economy. Continued funding is needed to support this important program.

Each dollar reimbursed to participating DA BUX food retailers for their issued discounts on local produce has an economic multiplier of 2.1. This means each program dollar issued for local produce incentives contributes \$2.10 to Hawai'i's economy. Additionally, if DA BUX was further scaled to food retail locations statewide, the potential economic contribution would be \$14-\$22 million in one year. The Hawai'i Healthy Food Incentive Program—DA BUX double up food bucks program—first started with a pilot program in 2012 through Kokua Kalihi Valley Comprehensive Family Services on O'ahu and The Kohala Center on Hawai'i island. The program provides a dollar-fordollar match to supplemental nutrition assistance program beneficiaries who purchase locally grown fruits, vegetables, and proteins at participating farmers' markets, grocery stores, and community-supported agriculture projects.

By the end of 2021, the pilot program was available at 57 food retailers across 98 market sites and pick-up locations that include grocery stores, farmers markets, community supported agriculture programs, and other farm direct retailers. From 2020–2021, DA BUX supported 470 farm producers and 8 distributors.

Each dollar reimbursed to participating DA BUX food retailers for their issued discounts on local produce has an economic multiplier of 2.1 times. This means that each program dollar issued for local produce incentives contributes \$2.10 to Hawai'i's economy. A \$3,000,000 investment by the state in this program would allow for a federal funding match that will contribute at least \$12,600,000 to our local economy annually.

#### Comments:

Over the course of the last 3 years, I've been working with DA BUX to market and promote the program online. I've had a lot of time to think about the program, its mission, target market and, on a more fundamental level, if the program even works.

I've concluded that it is a worthy program, it brings value to the community through both helping to create healthier more vibrant people, but also as an economic stimulus to local food producers and retailers.

In a time where retail food is dominated by large corporations and maximum profits, it's clear that the cheapest, most affordable, and widely appealing foods are also the most unhealthy—loaded with sugars, salts and fillers to get people hooked and coming back for more.

Healthy options like fruits and vegetables are more expensive and already at a disadvantage when it comes to appeal. And with inflation, the cost of fruits and vegetables have increased dramatically—even more so for local food producers who don't have the cost savings that come when operating at scale.

All this means that local fruits and vegetables are even more out of reach for low income families than ever before. But it's not just more difficult for low income families, it's also more difficult for the local farmers to compete and sell their products.

I've seen first hand that the DA BUX program is an effective mechanism to give low income families the chance to participate in the local fruits and vegetables market, which puts more money into the hands of our local farmers, and of course encourages those families to eat healthier.

The number one complaint about the program that I've heard is that it's not available in more locations. And since onboarding new locations requires a significant amount of resources and funding, it's the main limiting factor to making DA BUX ubiquitous in Hawaii, which is what I think would be the best case scenario.

Encouraging our local community to buy local fruits and vegetables, especially our lower income folks, is an almost impossible sell when local produce is at a premium and there are so many less healthy, cheaper options available. DA BUX makes it a no-brainer.

I believe this is an indispensable program to have in our community and I would implore you to do what you can to keep it going. Thank you for your consideration and taking the time to hear a concerned member of the community.
