The HPD opposes this bill that would allow operators of bicycles, motorcycles, and mopeds to proceed through an intersection on a steady red signal during certain hours if the traffic signal is controlled by a vehicle detection device that is inoperative due to the size or composition of the bicycle, motorcycle, or moped.

If this bill were to pass, it could increase the chance of a collision, as a result of motorists not expecting bicyclists, motorcycles, or mopeds to be crossing at an intersection against a red signal.

There have been too many times when I was forced to sit through multiple cycles of a traffic light becasue it could not detect my motorcycle, even though I was directly in the magnetic grid. This forced me to either (a) Get off the bike, run to the corner and trigger the pedestrian button to force the light to change and run back to the bike; (b) wait for another, larger vehicle to come up behind or next to me to trigger the light; or (c) check carefully both ways and run the non-changing light. Two of the three options have increased safety risk I prefer not to have to take. Mahalo!
