Good Morning Chair Rhoads, Vice Chair Gabbard & Senate Judiciary Committee Members,

# Please do not aid and abet child and human traffickers by not including safeguards into this measure!!!

As a Domestic Violence Survivor Advocate, I have a constant eye on how rules, laws, policies and procedures may be exploited by abusers and/or other parties with unholy intentions, so while the emancipation of a minor is clearly a family matter, my concern is what could happen if an unrelated third party were to be involved, ie: an abuser or child/human trafficker.

On Page 11, Lines 3-5 please consider adding:

### "and in absence of undue influence or coercion by any third party;"

So the line will read:

(3) The minor resides separately and apart from the minor's parents or guardian at the minor's own will, with or without the parents' or guardian's consent, and in absence of undue influence or coercion by any third party;

On Page 11, Line 18-19 please consider adding

### "or by any other third party;"

So the line will read:

(8) The minor is not seeking emancipation under duress, including by coercion of a parent, or guardian or by any other third party;

The appointment of a guardian ad litem should safeguard the process as well as flush out or make known any nefarious third party involvement, BUT if a comprehensive professional assessment of the situation (to include interviews with the minor parents or guardians) is not a part of HB349, may I strongly suggest that such investigative wording be included. Such wording serves as a deterrent and will help to ensure that the court does not inadvertently emancipate a minor from protective parents and place him/her into the captivity of an abuser or child trafficker waiting for such a decision.

Thank you for this opportunity to provide safeguard recommendations to HB349 HD2.

#### TESTIMONY IN OPPOSITION OF HB349: NO EMANCIAPTION LOOPHOLE FOR CHILD MARRIAGE IN HI

#### PRESENTED TO THE SENATE COMMITTEE ON JUDICIARY ON MARCH 14, 2023

Chair Rhoads, Vice Chair Gabbard and Distinguished Committee Members:

Thank you for this opportunity to present testimony on HB349. AHA's opposition to HB349 is limited to its creation of an emancipation loophole in the marriage laws, which furthers child marriage, a recognized human rights abuse. AHA respectfully requests that you amend HB349 by striking "Marry" from proposed subsection (c)11 of Section 577-25 of the bill.

Child marriage, or marriage before 18, is currently legal in Hawaii. The current marriage laws in Hawaii emancipate minors upon marriage. While this is already problematic and dangerous for many reasons, including teen homelessness (minors may become financially dependant on their spouses, but 70-80 percent of child marriages end in divorce, and following a minor's marriage parents are no longer responsible for them), HB349 would create a new loophole in the marriage laws, allowing emancipated minors to enter into marriage. HB349 must be amended to remove this dangerous new loophole.

First, emancipation is intended to help children who cannot be reunited with their parents, not to enter minors into contractual sexual relationships.

Second, emancipation gives minors some limited rights of adulthood, ones which are needed to navigate the world alone, but an emancipated minor is not an adult and marriage is not a necessity for minors. Just as emancipation under HB349 would not give minors in Hawaii the right to vote, buy alcohol or use tobacco products until they reach the age required for those activities, HB349 should not allow minors to marry before 18, especially given the many serious harms of marriage before 18.

Third, as emancipated minors' legal rights are limited, a marriage involving an emancipated minor can easily be forced. An emancipated minor may still might have problems leaving home, entering a shelter or taking other steps to escape an unwanted marriage. Emancipated minors might face obstacles accessing even the rights they do have because of practical barriers. For instance, a landlord may be hesitant to rent an apartment to a 16-year-old minor, even one that is emancipated.

Fourth, allowing marriage for emancipated minors creates the horrific possibility that parents who are determined to force a child to marry will first force the child to emancipate. It also eliminates what may be the only option advocates have to assist a minor being forced to marry. Our allies encountered this first-hand, immediately following enactment of an emancipation for marriage loophole in Texas. Parents were planning to take their daughter abroad to force her to marry, and our allies were unable to help that minor seek emancipation for fear the parents would simply force their daughter to marry at home. Had this exception not existed, the minor would have had two years to complete her education and create a plan.

Fifth, marriage before 18 creates devastating, lifelong consequences for girls. Child marriage destroys girls' economic and educational opportunities and jeopardizes their physical safety. The many repercussions of child marriage do not disappear by stamping "emancipated" on a girl's forehead. Various data demonstrating the harms of child marriage for girls include data on emancipated minors, as in certain places such as Hawaii, minors are emancipated upon marriage.

There has been legislation pending this session to eliminate the existing loopholes in the law that allow child marriage in Hawaii. We respectfully request that you **amend** HB349 by striking "Marry" from proposed subsection (c)11 of Section 577-25 of the bill, in order to not create a new loophole that advances child marriage, and can be used to abuse and exploit minors.
