In Consideration of HOUSE BILL 712, HOUSE DRAFT 1, SENATE DRAFT 1 RELATING TO RECORDINGS OF PUBLIC MEETINGS

House Bill 712, House Draft 1, Senate Draft 1 proposes to 1) encourage boards and commissions to maintain electronic audio or visual recordings after meeting minutes have been posted; amends the information that must be included in the written minutes of a meeting; 2) require a link to the electronic audio or video recording of the meeting to be placed at the beginning of the minutes and 3) require boards to provide the state archives with a copy of any electronic or visual recording before removing it from a board's website. This version of the bill does not propose to exempt licensing boards from provisions contained in Section 92-3.7 (b)(6), Hawaii Revised Statutes (HRS). The Department of Land and Natural Resources (Department) supports this measure as it clarifies what is required in written minutes and encourages, rather than requires boards to keep audio and visual recording for as long as feasible, rather than permanently. However, we defer to licensing boards regarding the practicability of Section 92-3.7(b)(6), HRS, for their situation.

The Department supports this bill as it clarifies and simplifies what is needed in meeting minutes. It also requires the State Archives, rather than an agency to permanently store audio and video recordings of meetings. These issues have been a matter of disagreement for several legislative sessions. Mahalo for hearing this bill which provides relatively simple solutions to address the Department's concerns with previous bills. The Department notes that it is compliant with all of the provisions of this bill.

Thank you for the opportunity to submit testimony on this bill, which would statutorily provide that boards are "encouraged" to keep recordings of remote meetings on their website and required to provide such a recording to the State Archives before removing it from the website, and would require a board's written minutes for any type of meeting to include a link to an audio or video recording when a recording is available online. **The Office of Information Practices** (OIP) offers comments.

The bill's purpose clause indicates that it is a proposal of the Commission to Improve Standards of Conduct (Commission) formed pursuant to H.R. 9 of 2022. Please note that **OIP was not part of the Commission or consulted** by the Commission regarding this or other bills proposing amendments to laws OIP administers, so the proposal does not reflect input from OIP.

This proposal does not require boards to record meetings they would not be required to record under current law. Boards are currently required to record remote meetings "when practicable," and keep the recording available on the Senate Committees on Commerce and Consumer Protection and on Judiciary April 5, 2023 Page 2 of 2

board's website until the meeting minutes have been posted on the board's website. The proposal would **encourage** a board to keep a remote meeting recording on its website even after posting its minutes, and **require** it to provide a copy to the State Archives if it does remove the recording. The proposal would also require written minutes of any type of meeting, remote or otherwise, to include a link to an audio or video recording of the meeting when available online.

These requirements are not a significant change from existing law and do not seem likely to present a burden for boards. Because the proposal encourages but does not require boards to keep recordings posted online after minutes are posted, a board that is running low on storage space to host recordings of its remote meetings can remove the older recordings as needed, so long as it provides a copy to the State Archives first.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) appreciates the measure's intent, provides comments, and defers to the Department of Accounting and

General Services (DAGS), Hawaii State Archives.

PURPOSE: The bill encourages boards to maintain recordings of board meetings on the board's website regardless of whether the written minutes of the meeting have been posted. Requires boards to provide the State Archives with a copy of any recording of a board meeting before removing the recording from the board's website. Requires the written minutes of board meetings to include a link to the electronic audio or video recording, if available online. Effective 10/1/2023. (SD1)

The HD1 amended the measure by:

- (1) Exempting licensing boards under the Department of Commerce and Consumer Affairs from the requirement that boards record meetings open to the public and make the recording electronically available;
- (2) Specifying that written minutes need only include a link to a recording if the recording is available online; and

(3) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

The SD1 amended the measure by:

- (1) Eliminating the exemption for licensing boards under the Department of Commerce and Consumer Affairs from the requirement that board meetings be recorded; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.

DHS appreciates the intent of this measure which allows the recording of public board meetings when practical. However, DHS comments that for volunteer commissions that are not staffed or funded, or have limited funds, it would not be practical for them to maintain a consistent practice of recording and maintaining meetings open to the public. In the future, the Legislature may want to consider legislation that would provide centrally located resources, including training, that these volunteer boards and commissions can rely upon to assist them with technology and administrative support for the work of the boards or commissions.

Chair Keohokalole, Chair Rhoads and Members of the Committees:

My name is Nadine Ando, and I am the Director for the Department of Commerce and Consumer Affairs' (DCCA or Department). The Department supports this bill.

The purposes of this bill are to: (1) encourage boards to maintain recordings of board meetings on the board's website regardless of whether the written minutes of the meeting have been posted; (2) require boards to provide the State Archives with a copy of any recording of a board meeting before removing the recording from the board's website; (3) require the written minutes of board meetings to include a link to the electronic audio or video recording, if available online.

The Department appreciates the SD1 and finds that posting recordings of meetings the Department's website and submitting recordings to the State Archives will be beneficial for both the public and the State. This will also allow licensees and the public to view recordings of meeting and stay apprised of important information discussed by their respective boards. It is important to note that licensing boards and

commissions under Hawaii Revised Statutes (HRS) section 26-9, discuss licensing applications and the disciplining of licensees, topics which are confidential, and are not disclosed to the public. Because of this, meetings are spent in closed session (executive session (HRS section 92-5) or adjudicatory session (HRS chapter 91)) and therefore not recorded. The Department also appreciates that the State Archives will permanently store audio and video recordings of meetings before removing the recording from the board's website.

Chairs Rhoads and Keohokalole, Vice Chairs Gabbard and Fukunaga, and members of the Committees. My name is Peter Fritz. I am Hard of Hearing (HOH) and an individual with a disability. I have served as the Chair of DCAB and the State Rehabilitation Advisory Committee and I am an advocate for the disabled. I am testifying **in support** of this bill **with an amendment to ensure that recordings are accessible to HOH and Deaf individuals**. The **proposed amendment below** makes it clear that recordings are to be accessible to disabled individuals like me.

State and local governments need to comply with Title II of the Americans with Disabilities Act (ADA). Title II compliance standards are the standards for Section 508 of the Federal Rehabilitation Act of 1973 (29 U.S.C. 794d), as amended. Hawaii already looks to Section 508 for guidance to meet accessibility the standards. The Enterprise Technology Services (ETS) website states that ETS "looks to this standard [Section 508] for reliable guidance on meeting accessibility commitments and compliance for portal architecture sites." https://ets.hawaii.gov/accessibility-statement.

The proposed amendment below adds language (in red) to paragraph (6) on page 2 of the bill to incorporate the Section 508 standards.
