SUBJECT: HB 777 HD2 SD1 – RELATING TO BACKGROUND CHECKS.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) supports this bill. DHS respectfully requests that the measure be further amendments to effectuate the effective date upon approval and to correct a typo in the amendment at Section 3, paragraph (13), page 9, line 9 to read as follows:

PURPOSE: Authorizes the Department of Human Services to conduct background checks for current and prospective employees, volunteers, contractors, contractors' employees and volunteers, subcontractors, and subcontractors' employees and volunteers whose position places them or would place them in close proximity to certain minors, young adults, or vulnerable adults. Effective 6/30/2050. (SD1)

The HD1 defected the effective date and made technical amendments.

The HD2 amended the measure by:

[&]quot;(13) The department of human services pursuant to sections <u>346-2.5</u>, 346-97, and 352-5.5;"

- (1) Requiring background checks on subcontractors and subcontractors' employees and volunteers instead of contractors' agents; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

The SD1 amended this measure by:

- (1) Deleting technical amendments that would have renumbered and reordered the paragraphs in sections 378-2.5(d) and 846-2.7(b), Hawaii Revised Statutes;
- (2) Inserting an effective date of June 30, 2050, to encourage further discussion; and
- (3) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.

DHS appreciates the SD1 amendments renumbering and reordering sections 378-2.5(d) and 846-2.7(b) as they currently exist. However, DHS requests further amendment (to correct a typo in the SD1) in Section 3, paragraph (13), page 9, line 9, to read as follows:

"(13) The department of human services pursuant to sections <u>346-2.5</u>, 346-97, and 352-5.5;".

Having the statutory authority to conduct comprehensive national and State fingerprintbased criminal history record checks and periodic rechecks will allow DHS to obtain information directly from the Federal Bureau of Investigations and the Hawaii Criminal Justice Data Center. The public will benefit from the Department's ability to conduct State and national background checks as an added measure to ensure the health, safety, and well-being of minors, young adults, and vulnerable adults receiving child welfare, child protective, extended foster care, higher education supports, social services, and adult protective or community services from DHS.

The current pre-employment background clearance process includes the State of Hawaii name-based criminal history record check. It relies on prospective new hires to self-report any convictions outside of the State of Hawaii.

The proposed measure will impact the Department's Human Resources and Social Services Division staff to conduct additional State and national background checks and periodic rechecks of current and prospective employees, contractors, and their employees, subcontractors, and volunteers. The Department's budget request includes adding one permanent full-time position to conduct background checks and the necessary funds to support the position.

The additional procedures proposed by this bill may cause a delay in hiring prospective employees. Also, the Hawaii Criminal Justice Data Center may experience an increased demand for services.

Re: H.B. No. 777, H.D.2, S.D.1

The Hawai'i Civil Rights Commission (HCRC) has enforcement jurisdiction over Hawai'i's laws prohibiting discrimination in employment, housing, public accommodations, and access to state and state funded services. The HCRC carries out the Hawai'i constitutional mandate that no person shall be discriminated against in the exercise of their civil rights. Art. I, Sec. 5.

H.B. No. 777, H.D.2, S.D.1 would authorize the Department of Human Services to conduct national criminal background checks for current and prospective employees; volunteers; contractors; and contractors' employees, agents, and volunteers, who are in positions that require proximity to certain minors, young adults, or vulnerable adults, and amend § 378-2.5(d)(13) to incorporate the new DHS exception by adding § 346-2.5 to the list of exceptions to the § 378-2.5 (b) and (c) limitations on pre-offer inquiries and lookback periods for felony and misdemeanor convictions.

The HCRC does not oppose this narrowly drawn statutory exception. While HCRC has concerns about creation of overly broad exceptions and the creation of a "slippery slope" where exceptions would render the rule meaningless, we understand the need for exceptions when employees, contractors, and volunteers work with vulnerable persons such as patients, youth, clients, or students. The HCRC also cautions against allowing consideration of records of arrest without conviction, as such arrests are without substantial legal meaning. The HCRC offers no opposition to the narrowly drawn exceptions to HRS § 378-2.5 regarding arrest and court records proposed in H.B. No. 777, H.D.2., S.D.1.

Hawai'i Health Systems Corporation ("HHSC") **supports** HB 777, HD2, SD1, offers additional comment on Section 3 of the bill regarding the consideration of prospective employees' conviction records under Section 378-2.5(d), Hawaii Revised Statutes (HRS), and **respectfully requests an amendment to this measure that HHSC be specifically listed as an exempted employer under this subsection.**

Section 3 of the bill specifically amends HRS Section 378-2.5(d)'s provision regarding an employer's inquiry and consideration of a prospective employee's criminal conviction record to exempt certain listed employers from its application. While HHSC is covered under Subsection (d)(1) of HRS Section 378-2 (identifying "The State or any of its branches, political subdivisions, or agencies pursuant to sections 78-2.7 and 831-3.1") as an exempted employer, HHSC requests that it be specifically listed as an exempted employer to read:

(19) The Hawaii health systems corporation pursuant to sections 78-2.7, 323F-5.5, and 831-3.1

Page 2 HB 777, HD2, SD1

Specifically identifying HHSC as an exempted employer reflects HHSC's status as a separate jurisdiction established under Chapter 323F. It would also recognize critical and sensitive employment challenges inherent in HHSC's health care operations.

Comments:

I support HB777, HD2, SD1 because it would provide national background checks for licensed or certified community-based care homes, care centers, early learning centers and staff who care for our minors as well as elderly and the disabled being under the purview by either the Department of Human Services or Department of Health.

HB 777, HD2, SD1 would require the state Department of Human Services to conduct much broader background checks including obtaining fingerprints, searching through criminal histories and looking into past employers for their applicants.

As an example of how the system works now, the DHS has oversight of the state's early education services, community-based services, and some nonprofit services including those providing guidance to kids. But it also has been legally limited in its background checks of applicants to state-only databases, relying on job applicants to self-disclose any other convictions.

This bill will provide for a national background check which will provide enhanced protection for Hawai'i's minors, elderly, and disabled.
