Thank you for the opportunity to testify on this bill.<sup>1</sup> The Campaign Spending Commission ("Commission") supports this bill with an amendment.

This bill amends Hawaii Revised Statutes ("HRS") §11-405(a) to allow for the service of the commission's preliminary determination of probable cause ("PDPC") by first-class mail **and electronic mail** sent to the addresses provided by the committee in the committee's organizational report filed with the Commission. The bill also creates a presumption that the committee received the PDPC within five business days of the PDPC being mailed.

Presently, the Commission is required to serve the PDPC by certified mail. The Commission, in addition to certified mail, has been sending the PDPC by first-class mail. In several cases, although the document sent by first-class mail was not sent back to the Commission as undeliverable, the document sent by certified mail was not claimed by the committee and was returned to the Commission. Since there was no service by certified mail, the Commission was unable to enforce its order and the case remains in limbo. Allowing the Commission to serve the PDPC by first-class mail will allow the Commission to proceed with enforcement of its orders.

The Commission also asks this committee to **delete** the requirement for service of the PDPC via electronic mail (page 1, line 10). Under existing law, committees are not required to provide an electronic mail address in their organizational report. HRS §§11-322, 11-323. Thus, the Commission will not be able to routinely serve the PDPC via electronic mail.

The Commission requests that this committee pass this bill with the recommended amendment.
