1 Fiscal Implications: None.

2 Department Testimony: Thank you for the opportunity to testify in STRONG SUPPORT of

3 HCR205, which requests that the Legislature: recognize and support "ongoing collaborative

4 efforts by state agencies and private organizations to implement the "Hep Free 2030" statewide

5 strategy to eliminate viral hepatitis types A, B, and C in Hawaii"; prioritize hepatitis elimination

6 as a State public health concern; and convene an informational briefing in 2023 on the status of

7 the strategy's implementation and to determine any legislative recommendations.

8 Hawai'i has one of the highest incidences and mortality rates in the country for liver cancer,

9 primarily due to viral hepatitis. Recently, the department released a report that found rates of

10 hepatitis B-associated deaths in Hawai'i were higher than the U.S. average every year for two

decades (2000-2020). In 2019, the hepatitis B mortality in Hawai'i was three times higher than

12 the national average. Furthermore, the report found consistently higher death rates due to

13 hepatitis B among Asian and Pacific Islander residents, compared to the rest of the state.

14 Additional research from the U.S. Centers for Disease Control and Prevention has shown that

15 hepatitis C infection in Hawai'i can reduce life expectancy by 20 years. Hawai'i is also the state

16 with the highest proportion of Native Hawaiian, Asian, and/or Pacific Islander decedents among

17 hepatitis C deaths nationwide (from 2016-2017). Notably, hepatitis B and C are preventable and

18 treatable (hepatitis B) or curable (hepatitis C).

1 To address this public health priority, the department has partnered closely since 2011 with a

- 2 wide array of state and community partners as a member of the Hep Free Hawai'i coalition. The
- 3 department has an ongoing advisory role in the development and implementation of "Hep Free
- 4 2030: The Hawai'i Hepatitis Elimination Strategy 2020-2030" to ensure alignment with
- 5 recommendations and priorities of the department, the U.S. Centers for Disease Control and
- 6 Prevention, the U.S. Department of Health and Human Services, and the World Health
- 7 Organization. Furthermore, the Hawai'i "Hep Free 2030 Strategy" is the first in the nation to

8 commit to eliminating hepatitis A, B, and C, positioning the State and the department as thought

9 leaders and innovators in public health.

10 As such, the department submits this testimony in STRONG SUPPORT of HCR205 so that the

11 Legislature can formally recognize the successes of ongoing public-private partnerships in public

12 health and to continue to learn more about the importance of viral hepatitis elimination as a

13 priority for Hawai'i.

As a public health professional and concerned community member, I write in STRONG SUPPORT of HCR 205, which highlights Hep Free 2030 (the statewide hepatitis elimination strategy); recognizes the Hep Free Hawai'i coalition's efforts to make our state truly hepatitis free; and offers an informational briefing on viral hepatitis to the legislature before the next legislative session.

Hawai'i is on the forefront of hepatitis elimination efforts and has been a leader and inspiration for states and entities doing work in this field. This resolution is important because of the extraordinary burden of viral hepatitis on the people of Hawai'i. A recent Hawa'i DOH report demonstrated that death rates associated with hepatitis B are 3 times higher than the national average, especially impacting Asians and Pacific Islanders.

Shockingly, a Hawai'i resident with hepatitis C is expected to die 20 years earlier than the average Hawai'i resident! (https://academic.oup.com/cid/article/71/5/1149/5581721)

Clearly, this is an important public health issue that needs more attention. HCR 205 will support Hawai'i to keep our local communities healthy and safe and "hep free".

Aloha Senators of the Committee on Health and Human Services, Chairwoman Senator Buenaventura and Vice Chair Senator Aquino.

I believe that we can reach the goal of a Hep Free 2030. I believe that expanding MedQuest to cover Hep C medications will help to attain this goal. Hep C direct-acting antivirals are effective, well tolerated and generally can be eradicated with one to three pills a day for twelve weeks (Lombardi, et al., 2019).

Enacting a syringe service, immunizing against Hep A in homeless communities as well as identifying and supporting foreign born women and families that are at high risk of contracting hepatitis B are all steps in the right direction and show this is a priority.

Additional action to show this is a priority might also include no cost testing for Hepatitis A, B, and C to identify those infected and those that need vaccination for Hepatitis A and B. For anyone with advanced liver disease after eradication of the virus, should also be in a surveillance program (Lombardi, et al., 2019). As is stated in the resolution, hepatitis B & C can lead to liver cancer and Cirrhosis as well as decrease the life expectancy. With deaths from Hep B higher in Hawaii than in other parts of the US, ongoing care needs must be considered as part of the plan for Hep Free 2030.

I support the resolution with added considerations.
