It will also address additional considerations resulting from recent appropriation language, and refine the prior CMs that were developed collaboratively with the Comptroller's Office, the Department of Accounting and General Services – Public Works Division, Department of Budget and Finance, Office of the Attorney General, and the State Foundation on Culture and the Arts.

The Comptroller, as the Director of DAGS, will continue to work with these agencies to ensure appropriate transfers of funds are transacted and to help identify those projects that did not correctly transfer funds in the past.
