## Testimony COMMENTING on HCR94 REQUESTING THE DEPARTMENT OF HEALTH TO PRIORITIZE TESTING AND RESEARCH OF BEACH SAND CONTAMINATION LEVELS AT POKAI BAY AND REQUESTING THE CITY AND COUNTY OF HONOLULU DEPARTMENT OF PARKS AND RECREATION TO PRIORITIZE RENOVATIONS OF THE RESTROOM FACILITIES AT POKAI BAY

- 1 Fiscal Implications: This measure may impact the priorities identified in the Governor's
- 2 Executive Budget Request for the Department of Health's (Department) appropriations and
- 3 personnel priorities.

4 Department Testimony: The Department understands the intent of this measure and

5 respectfully offers the following comments regarding HCR94.

6 The Department currently monitors the water quality of Pokai Bay and prioritizes it as a

7 Tier 1 beach which receives weekly water quality monitoring for the fecal indicator bacteria,

8 enterococci. Between January 2019 and March 2023, the Department collected 192 water quality

9 samples in Pokai Bay, of which 4 samples exceeded the Beach Action Value (BAV) of 130/100

- 10 mL. In each of these instances, follow-up samples collected on the next working day did not
- 11 exceed the BAV, indicating that there were no ongoing water quality issues in the bay.

12 The Department does not test sand for the presence of fecal indicator bacteria. There is no 13 approved or proven reliable testing method, nor is there a threshold or action limit associated 14 with health risks due to contact with sand. These parameters would need to be developed -- the

- 15 Department does not have the resources to conduct this type of research. Lacking this
- 16 information, current procedures and actions cannot be reliably and defensibly applied to sand
- 17 testing. Until a reliable test method is developed and a defensible standard or action threshold is

1	established for fecal indicator bacteria levels in sand, the Department is not able to carry out the				
2	same procedures and actions under the routine monitoring program.				
3	The proposed resolution urges the Department to develop a plan to increase water				
4	circulation at Pokai Bay to improve water quality and mitigate environmental and health risks				
5	caused by pollution and contaminants in the water. The Department does not have the authority,				
6	resources, or expertise to alter or increase circulation in waterbodies. The Department is				
7	authorized to control land based point and nonpoint sources of water pollution.				
8	Offered Amendments: The Department offers the amendments below.				
9	On Page 2, Line 24:				
10	WHEREAS, the Department of Health has the supplies to test seawater and occasionally				
11	tests the seawater in Pokai Bay specifically for fecal indicator bacteria, which decays at slower				
12	rates in the beach sand than in seawater; [now, therefore,]and				
13	WHEREAS, the Department of Health tests the waters of Pokai Bay for the fecal				
14	indicator bactiera, enterococci on a weekly basis and has found that of the 192 water samples				
15	collected between January 2019 and March 2023, four samples exceeded the action limit of				
16	<u>130/100 mL; now, therefore,</u>				
17	BE IT RESOLVED by the House of Representatives of the Thirty-second Legislature				
18	of the State of Hawaii, Regular Session of 2023, the Senate concurring, that the Department of				
19	Health is urged to continue to prioritize testing [and research ]of fecal indicator bacteria levels				
20	and any other pollutants of the [beach sand at ]waters of Pokai Bay; and				
21	BE IT FURTHER RESOLVED that the Department of Health is urged to make testing				
22	and research of fecal indicator bacteria levels and any other pollutants in [beach sand at-]Pokai				
23	Bay a priority of the Department's non-point source pollution program; and				
24	BE IT FURTHER RESOLVED that the Department of Health is urged to [develop a plan				
25	to increase water circulation at Pokal Bay to improve water quality and mitigate environmental				
26	and health risks caused by pollution and contaminants in the water; and]				
27	[BE IT FURTHER RESOLVED that the Department of Health is requested to				
28	collaborate with other appropriate state and county agencies to develop the plan to increase				
29	water circulation; and]address land based point and nonpoint sources of water pollution into				
30	<u>Pokai Bay.</u>				

1	[BE IT FURTHER RESOLVED that the Department of Health is requested to submit a			
2	report of its collaborative activities, including significant findings, cost estimates, and any			
3	proposed legislation to increase water circulation at Pokai Bay, to the Legislature no later than			
4	twenty days prior to the convening of the Regular Session of 2024; and]			
5	BE IT FURTHER RESOLVED that [based upon the Department of Health's testing and			
6	research of fecal indicator bacteria in the beach sand at Pokai Bay,] the City and County of			
7	Honolulu Department of Parks and Recreation is requested to prioritize renovations of the			
8	restroom facilities at Pokai Bay; and
