## TESTIMONY BEFORE THE SENATE COMMITTEE ON TRANSPORTATION AND CULTURE AND THE ARTS ON SB 1173 RELATING TO VEHICLES

Aloha Chair Lee and committee members. I am Gareth Sakakida, Managing Director of the Hawaii Transportation Association (HTA) with over 350 transportation related members throughout the state of Hawaii.

Hawaii Transportation Association opposes this bill.

First, we cannot imagine any commercial driver INTENTIONALLY discharging soot or smoke upon any person or vehicle. Most exhaust systems are vertical stacks which are not conducive to "aiming at a target."

Anyone, be it pedestrian or vehicle occupant can claim having soot or smoke discharged at them, but how do you prove the action is intentional?

Advances in emission technology have come a long way with diesel particulate filter systems that capture and burn off soot. However, when pulling heavy loads like our commercial vehicles are designed to do, and/or while accelerating it is still possible to see some smoke even though the particulates are trapped.

There have been many advances in emission technology since the mid 2000's, and today the emission advances tout "near zero emissions." Many claim entrapment of particulates up to nearly 100%, but exhaust gases are still emanated, no matter how clean. This exhausting can easily be mistaken for soot or smoke when one chooses to perceive a violation.
