Thank you for the opportunity to testify on this bill. The Campaign Spending Commission ("Commission") provides the following comments on this bill.

This bill adds a new section to Chapter 11, Hawaii Revised Statutes ("HRS"), that would require candidates, who are incumbent office holders seeking election to the Senate or House of Representatives, to file a report within ten days of receiving a contribution aggregating more than \$500 from any person during a legislative session. If the measure is adopted, the large contribution report will be the only disclosure report that applies only to incumbent candidates. Also, HRS §11-338 already requires all candidates on the ballot (and noncandidate committees) to report all contributions that aggregate more than \$500 that are received between fourteen calendar days and four calendar days before an election in a late contributions report due three days before an election.

Finally, the Commission asks this committee to make this measure effective after the 2024 general election so the Commission has sufficient time to modify its electronic filing system to implement the new report.
