## **RELATING TO MEAT PROCESSING**

## Chair Gabbard, Chair Inouye and Members of the Committee:

Maui County Farm Bureau (MCFB) appreciates this opportunity to testify on this important issue. MCFB is a general agriculture advocacy organization representing farm and ranch families and organizations on the island of Maui.

MCFB STRONGLY SUPPORTS SB1486, seeking to develop a process to utilize feral animal meats for food as a long term sustainable solution to manage feral animal populations.

Everyone recognizes that we have a axis deer overpopulation problem. In defense, fences are being erected to protect property. However, this does not address the need to reduce populations. Concurrently, there is a public desire to utilize the animals for beneficial use. Other states have developed programs such as "Farmers & Hunters Feeding the Hungry" <u>https://feedingthehungry.org/</u> that work and can be utilized as templates for a program for Hawaii.

These programs address the gap between the hunter and distribution to the needy. The process will require coordination as well as development of sustainable funding mechanisms. This proposal seeks to develop such a working group. A side benefit from this effort will be addressing the need for additional meat processing capacity in Hawaii, especially for multi species needs of our smaller farmers and ranchers. Cattle past their prime processing time loses value. Currently ranchers often suffer significant loss waiting for processing opportunity. Maui has a hog processing plant that will cease when the current operator retires due to conditions of the land use permit. Expansion of processing capacity will help address this problem.

Covid demonstrated the need for smaller plants. Federal funding is available for CIP needs while programs such as Feeding the Hungry provide templates for long term operation. Hawaii needs a long term strategy to manage feral wildlife populations. This is a step in that direction. MCFB respectfully requests your strong support of this measure and assistance in identifying workable strategies.

SB1486 includes a very important aspect in addressing the problem which is development of grassroots support. The measure defines the process by which the program is to be developed, recognizing the role of the various parties. It additionally addresses funding needs.

Aloha Chairs Gabbard and Inouye, Vice-Chairs Richards and Elefante, and Members of the Committees:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports HB 1486, which requires the Department of Agriculture, in collaboration with the Hawai'i Interagency Council on Homelessness; Department of Land and Natural Resources, Division of Forestry and Wildlife; and Department of Health, Food Safety Branch, in consultation with the County of Maui Axis Deer Task Force, to develop and implement a plan to expand the meat processing capacity in the State to allow for meat from axis deer and other wild game to be processed for distribution by nonprofit food distribution services.

Across the State, various invasive species are creating havoc in agriculture as well as the ecosystems in which they exist. Maui County's Axis Deer population is a good example of nature getting out of control with populations exploding due to abundant forage following rainfall events. They continue to destroy crops and pasture lands by devouring any living vegetation as they continue to spread. Feral pigs damage crops by consuming them or by their rooting and trampling of crops. They will eat almost any crop. Feral pigs damage pasture grasses, killing desired plant species and often encouraging the growth of undesired weed species. They can also devastate orchards by consuming fruit, citrus, and nuts and their rooting can severely damage, or even kill saplings, shrubs, and vines directly or by facilitating the spread of soil-based fungal diseases. Feral pigs can also break irrigation lines, rip or tear nets, drying racks, and other agricultural structures and equipment.

These and other feral populations can pose a danger, especially as populations grow and their health is put into jeopardy due to inadequate food. Diseases that they normally

tolerate will become serious debilitating illnesses that could put our domestic livestock industry in jeopardy. Such fears are not unreasonable, as incidences such as bovine tuberculosis spread from feral pigs have been documented in Molokai.

Hawai'i's farmers and ranchers are working to provide Hawai'i with an increased level of self-sufficiency, but will not be able to do so if their products are consumed or damaged by feral animals. Axis Deer, feral pigs, and other invasive species can cause major damage to property, agriculture (crops and livestock), Hawai'i's native species and ecosystems, and Hawai'i's cultural and historic resources. They can also threaten the health of people, wildlife, pets, and other domestic animals. As Hawai'i's feral animal populations continue to expand, these damages, costs, and risks will only keep rising

Current state law specifically prohibits the inclusion of meats as a donation. Wild game can be a significant source of protein for Hawai'i's residents in need. Wild game can provide a beneficial outlet for meat harvested from invasive species and provide a tool for long-term sustainable invasive management for Axis Deer and Feral Pigs.

Several states have amended their Good Samaritan laws to use them as a tool for invasive white-tail deer management programs. Wild game meat donated under this provision does not need to undergo antemortem inspection requirements as long as stated conditions are met. Conditions for donations can be specified to allow the donation of this important protein source for our neighbors in need. Utah is the most recent state that passed such a measure and can be used as a model for Hawai'i.

### Comments:

I serve Maui based non profit Feed My Sheep as Executive Director and have been with the organization since 2008. In my position at Feed My Sheep, providing nutrition assistance to thousands of Maui residents, I have long held that the axis deer population is a reservoir of nutrition for our residents, particularly those in greatest need. As the situation stands, a number of barriers to employing this meat for its highest and best use are unresolved. Vulnerable households suffer for lack of access. For this reason, I support SB1486 "to expand the meat processing capacity in the State to allow for meat from axis deer and other wild game to be processed for distribution by nonprofit food distribution services."

I have witnessed axis deer becoming a growing problem to the Maui agriculture industry for well over a decade. As early as 2012 I have advocated before the Maui County Council that axis deer should be addressed not only as a nusance to farmers, but also as an asset for Hawaii's poor. Charitable organizations such as Feed My Sheep lean heavily on the profitability of local food producers whether in better pricing or more abundant donations. Numerous times, donating farmers and vendors have informed us they would have more food for us if not for axis deer destroying product.

Harvesting the axis deer would leave more undamaged produce for donation and lower costs to farmers. Processing axis deer meat and other wild game would open up a new stream of vitamin-rich protein and eliminate nutritional gaps for thousands of Hawaii Residents.

Unfortunately, the processing capacity does not match supply or demand. During the COVID pandemic Feed My Sheep was fortunate to work with the Maui County Mayor's office administering CAREs act funds for local nutrition sourced from local producers. This included beef from independent Maui cattle ranchers. We discovered Maui meat processors struggled following decades of out-of-state competition and lack of skilled workers. Cattle farmers with essential product outstripped the capacity of meat processing facilities and this friction harmed all parties

With no other assistance or relief, simply requiring existing facilities to process axis deer would compete for capacity with local ranchers and compound existing issues. Action from the State of Hawaii with input from the agencies identified in the bill, is a promising pathway for a sustainable, fair and legitimate solution. I look forward to seeing axis deer meat employed as a resource for the poor while also reliving problems for ranchers and food producers who have supported Maui for generations and I support SB1486 in light of those potential benefits.

The Chamber would like to point out that axis deer, an invasive species that poses a continuing threat to Hawaii's environment, could provide significant quantities of meat as a protein source for nonprofit food distribution services, such as the State's network of food banks and Feed My Sheep, Inc. of Maui County. However, there is a gap between the hunters and the retailers and nonprofit services because the meat requires processing prior to distribution. For meat donation, other states such as Wisconsin and Michigan offer models that Hawaii can assess to develop processes for plan implementation and program funding, including licensing fees and other funding sources managed by wildlife agencies or nonprofits.

This bill will be one of a few major tools in controlling the over-population of Axis deer on all islands.

For these reasons, we support SB1486.
