Comments:

While I appreciate the strengthening of voter protection that this bill includes, I find the main subject of the statement about voting in more than one location as I believe that it will have unintended consequences for dual residents, for example, a Hawaii resident who goes participates in the local election of their mainland school/university. Furthermore, it can be unfair for those who reside and pay taxes in two different states. Therefore, I suggest the bill amends the current statute to allow those with dual residency in other states to vote in local and state elections since the outcome of the polls affects their domicile. However, I would like the bill to specify that dual residential voters only apply to state elections and that representatives, such as presidential and DC representatives, can only vote once for federal elections.

Another reason I do not fully support the bill is that I feel the bill's protection against voter fraud when it comes to voting more than once in the same election is already sufficient and that this bill is redundant. Because despite the hysteria on election fraud over the year, the actual instances of it happening is very rare. For example, between 2000 and 2012, it was speculated that the number of voter fraud committed was as high as 200 and low as 13. As <u>The Brennan</u> <u>Center for Justice</u> put it, "it is still more likely for an American to be struck by lightning" than to commit voter fraud through in-person voting or with mail ballots."

Overall, while I appreciate this bill's intent, I feel it should be focused more on protecting voters from harassment than playing securing circus with the residents of Hawaii.
