Dear Senator Keohokalole, Senator Dela Cruz, and Committee Members:

SUBJECT: SB389 RELATING TO EQUITY

The Hawaii State Council on Developmental Disabilities **SUPPORTS SB389**, which requires all places of public accommodation and state building construction constructed after 12/31/23 to provide universal changing accommodations that are equally accessible to men and women.

Families and caregivers of people with disabilities that require changing facilities want to participate in as many activities and outings as possible. At the same time, they must plan out or research their trip or daily activities to include accessible spaces along their path of travel, taking into consideration the disability-friendly rest areas that provides a safe and dignified toileting area along a certain route.

Implementing universal changing accommodations will ensure Intellectual and Developmental Disability (I/DD) community members have more equity in access, removing barriers to travel that currently affect full participation and integration in daily activities. This will greatly benefit the I/DD community's access to public spaces.

#### Comments:

We think this an excellent idea. Since 2016, federal law has required baby changing accommodations in both male and female restrooms in publicly-accessible federal buildings. Since then, some states have enacted laws creating Universal Changing Stations which allow changing accommodations to also include adults in public buildings. The problem quite simply is that many adults with disabilities are just too heavy for infant changing tables. Clearly, a person's inability to utilize conventional restroom facilities directly affects their ability to enjoy and fully participate in community based activities.

Many of Hawaii's restrooms have family bathrooms but these restrooms do not have adequate restroom facilities for larger children and seniors who need to change their incontinent supplies. The lack of access to accommodating changing stations limits a person's ability to leave home to engage and participate in daily activities. This legislation would really help to create a more inclusive environment in the community for those with disabilities.

#### <u>Re: H.B. No. 1145</u>

The Hawai'i Civil Rights Commission (HCRC) has enforcement jurisdiction over Hawai'i's laws prohibiting discrimination in employment, housing, public accommodations, and access to state and state-funded services. The HCRC carries out the Hawai'i constitutional mandate that no person shall be discriminated against in the exercise of their civil rights.

The HCRC offers these comments on S.B. 389, which requires all new establishments, defined as public accommodations or state building construction constructed after December 31, 2023, to provide universal adult changing accommodations that are equally accessible to men and women.

The measure proposes a new part to the statutes, and places it within Chapter 489. Noting that the HCRC has jurisdiction over discrimination in public accommodations under Chapter 489, Part I, the HCRC appreciates the placement of this new adult changing station requirement in a new part, expressly excluded from HCRC jurisdiction. In this respect, the new statutory requirement would be similar to Chapter 489, Part II, relating to Breastfeeding in Public Accommodations, which is also expressly placed outside of HCRC jurisdiction. This measure would significantly aid those with disabilities who need help with toileting, by providing safe and sanitary facilities, and would allow them to join friends and family members on outings. The lack of access to changing facilities can limit those with disabilities from leaving home. This bill will aid them and their caregivers.

The measure defines universal changing accommodations as a "powered, height adjustable adult changing station that is either floor or wall mounted." New Hampshire, California, and Arizona have enacted similar measures, that are more limited than this proposal. California's statute is limited to places of public amusement such as sports arenas or theaters, and New Hampshire's law is similarly limited to large establishments. Arizona's statute is only applicable to buildings built with public monies. In comparison, this measure would require universal changing accommodations in a broader range of establishments.

Aloha Chairs, Vice Chairs, and Members of Committees on Commerce and Consumer Protection and Ways and Means:

On behalf of the Epilepsy Foundation of Hawaii (EFH), we urge your **SUPPORT of Senate Bill 389**, RELATING TO EQUITY. This bill supports providing universal changing accomodations in all places of public accommodation and state building construction construction after 12/31/23.

The Epilepsy Foundation is the leading national voluntary health organization that speaks on behalf of the at least 3.4 million Americans with epilepsy and seizures. Epilepsy Foundation of Hawaii, advocates and provides services for the almost 14,000 individuals living with epilepsy throughout Hawaii. Collectively, we foster the wellbeing of children and adults affected by seizures through research programs, educational activities, advocacy, and direct services. Epilepsy is a medical condition characterized by seizures, which are sudden surges of electrical activity in the brain, that affects a variety of mental and physical functions. Approximately 1 in 26 Americans will develop epilepsy, and approximately 1 in 10 people will experience a seizure, at some point in their lifetime.

Epilepsy is a chronic medical problem that for many people can be successfully treated. Unfortunately, treatment doesn't work for everyone. AT LEAST 1 million people in the United States have uncontrolled epilepsy, which is considered a disability by the Social Security Administration (SSA). Epilepsy does not discriminate. It can effect anyone at any age, gender, ethnicity, or size, and is often times a comorbidity with other disease states. For many, their epilepsy is debilitating.

Universal changing stations are height adjustable and support weights up to 300+ pounds, alleviating the challenge of caregivers having to navigate changing kupuna, adults and older children with disabilities either in their cars or unsafe and unsanitary spaces. Universal changing stations in state and federal buildings would estability equity and inclusion to people who need a safe and sanitary space to change incontinent supplies in order for them to ensure continuity in community engagement in public spaces.

Re: SB 389 Relating to Equity

Dear Chair Keohokalole, Vice Chair Fukunaga, Honorable Members of the Senate Committee on Commerce and Consumer Protection, Chair Dela Cruz, Vice Chair Keith-Agaran, and Honorable Members of the Senate Committee on Ways and Means.

I am Gary Simon, a member of the board of the Hawaii Family Caregiver Coalition, whose mission is to improve the quality of life of those who give and receive care by increasing community awareness of caregiver issues through continuing advocacy, education, and training.

The Hawaii Family Caregiver Coalition supports SB 389, which requires all places of public accommodation and state building construction constructed after December 31, 2023 to provide universal changing accommodations that are equally accessible to men and women.

Disabled children, adolescents, and adults — over the height and weight limits of baby changing tables — requiring help with toileting cannot use regular handicapped-accessible bathrooms. Instead, there must be a choice to stay home from public spaces, be laid down on a restroom floor to be changed by their caregiver, or leave the public place or event as soon as they need the restroom to be changed inside a vehicle or return home. Universal changing spaces have height-adjustable, adult-size changing tables that accommodate everyone. These are necessary for public areas such as restaurants, hotels, venues, movie theaters, and zoos so that disabled individuals can have equal opportunities to engage in activities and travel. All disabled Americans deserve a safe, private, and dignified changing space.<sup>1</sup>

We urge you to support SB 389, we urge you to recommend its passage, and we thank you for seriously considering the Bill.

A person's inability to utilize conventional restroom facilities directly affects their ability to enjoy and fully participate in community based activities. As you plan and govern over new construction in public buildings, we ask for your support in installing universal changing stations so all individuals (keiki to kupuna) can attend to their sanitary and hygienic needs in a dignified way.

2016, the Bathrooms Accessible In Every Situation Act (BABIES Act) requires baby changing accommodations in both male and female restrooms in publicly-accessible federal buildings.

Since then, Arizona, California, New Hampshire, have enacted laws creating Universal Changing Stations which allows changing accommodations to also include adults in public buildings.

Many of Hawaii's restroom have family bathrooms but these restrooms do not have adequate restroom facilities for larger children and seniors who need to change their incontinent supplies. The lack of access to accommodating changing stations limits a person ability to leave home to engage and participate in every day activities. Family restrooms on Kauai are limited.

Yes, the installation of these units would increases the cost of new building constructions. However, I reached out to a company called Max Ability back in December 2022 for a quote on a unit called the Pressalit 3000. This unit is comparable to units used in airports around the country. With ocean freight, a unit into Hawaii would run \$12K. This would not include mounting and electrical connection by way of licensed contractors. I share these figures, with the hope that it provides an estimate of the cost involved. Units could be placed in gender neutral family restrooms in newly constructed buildings to be inclusive for all.

Appreciate the opportunity to provide testimony in strong support of this bill. These accommodations would greatly improve the lives of those with disabilities and our kupuna.
