Comments:

I am an appellate attorney with a longterm interest in the constitutional and public policy issues attendant on nonparent visitation litigation. I have submitted amicus briefs to the U.S. Supreme Court and many state supreme courts in cases involving these issues, and have testified before quite a few state legislative committees where bills to expand or restrict nonparent visitation litigation were being considered. I am pleased to testify in support of HB 406 SD1, with one caveat.

This bill would limit the number of potentially ruinous lawsuits impinging on fundamental, constitutionally protected parental rights, and would also clarify that the appropriate "clear and convincing evidence" standard is used. As amended, it would require the petitioner to prove, by that standard, that the visitation (if any) chosen by the custodial parent(s) would be harmful to the child. Grandparent visitation lawsuits are very likely to be as disruptive, intrusive, burdensome, and fiercely fought as divorce litigation. Resources that should go toward the children's education, extracurricular activities, and enrichment opportunities, or even their basic needs are instead consumed by legal fees. It is not uncommon for the expense to make it necessary for parents to take second jobs, thus reducing the time they can spend with the children. Moreover, any chance of a future beneficial and nurturing relationship between the children and the petitioner is greatly reduced as the petitioner acquires the status of an opponent, even an enemy. Parents may have many legitimate reasons for limiting or denying visitation with a nonparent. That nonparent may ignore parental rules and concerns; may facilitate contact with, e.g., problematic or incarcerated other relatives; may attempt to poison the child's mind against a stepparent or a parent's significant other; or may, good faith notwithstanding, be in denial about his or her physical and cognitive faculties and ability to safely care for a child.

My one caveat concerns section (d), which would require the trial court to be "guided by all standards, considerations, and procedures for parent visitation rights. . . ." These standards are designed for and appropriate to litigation concerning parental visitation, and are in many respects not suited to awards of the necessarily more limited visitation rights some grandparents may receive. It also includes, in section (7), language inconsistent with this bill, a problem which should at some point be corrected, and which will become more acute if section (d) is included in its present form.

**I am testifying in favor of SB 406** in allowing grandparents to file a petition with the court for an order of reasonable visitation rights if the parent of the minor is unable to file due to incarceration or death.

I have worked with at risk youth for over 15 years, in New York Cities Juvenile Justice systems and in Hawai'i's. **Children who have had parents incarcerated or the death of a parent are experiencing a traumatic event in their lives, and it is imperative for that judiciary to pass laws that practice trauma informed care.** Research has shown that part of building a resilient child is for that child to have supportive adult relationships in their lives. Grandparents often seen as "stress buffers", "confidants", "roots", family "watchdogs" "arbitrator" and "supporters".

Children have a right to familial relationships and to learn where they come from. Grandparents provide Grandchildren with important cultural and ancestorial lessons, important medical history as well as a sense of belonging.

For the best interest of the children and development I urge the committee to pass SB406. Mahalo nui for reviewing my testimony.
