Senate Bill 409 proposes to appropriate funds to the Department of Land and Natural Resources (Department) to reduce hazardous wildfire fuels on the landscape, particularly on lands adjacent to communities. **The Department strongly supports this measure.**

With changes in land use and climate in Hawai'i, wildfire is a significant and growing hazard in many places across the state. Research in wildfire science shows that vegetation is a key component for recurring wildfire. Dear Chair Inouye, Vice Chair Elefante, and members of the Committee on Water & Land,

We are in <u>strong support</u> of SB 409 which would appropriate funds to the Department of Land & Natural Resources to reduce hazardous wildfire fuels on the landscape, particularly on lands adjacent to communities.

The Hawai'i Fire Department is the primary response agency for fire in the County of Hawai'i, and works very closely with our partnering fire response agencies such as Federal Fire departments at PTA and State Dept. of Forestry and Wildlife (DOFAW). We collectively have seen many challenges with fighting wildland fires. Over the years we have seen an increase in wildland fires and fire intensities due to various reasons, one of them being the effects of weather. Due to the changes in weather patterns and different types of fuel loads with invasive species spreading fast over our landscapes, the challenges of being able to effectively fight fires have increased significantly.

Another challenge for us here on the Big island, is the large geographical area and open land without infrastructure or resources to support our firefighting efforts. With that being said, having additional support to fund mitigation and prevention efforts on the front end, we could potentially eliminate fires or at the very least, limit the amount of fire spread and intensity when a wildfire does start. As many of you know, we recently had that largest wildfire in history on Hawai'i Island, and it visciously burned through and burned 3 structures including a residence, in a DHHL homestead (Pu'ukapu Farm Lots). Wildland Urban Interface (WUI) fires are extremely dangerous, because it affects people and lives. With weather patterns continuing to trend in an unfavorable direction, we all need to be better prepared to minimize the risks and hazards that they pose to our community.

The Hawai'i Fire Department has partnered with The Hawai'i Wildfire Management Organization to help mitigate hazards and educate our communities to better prepare



themselves for wildfire threats. But we also need to manage fuels and landscapes to match the efforts and buld a better and safer community.

Along with the topics shared above, and just as importanly if not more, are the safety of the men and women on the ground, in the field who are fighting these intense wildfires. Our primary mission as Fire Fighters is to assure the safety of our community. If we are not able to keep our personnel safe, we would not be able to assure the safety of the community.

We support the passage of this bill because we know vegetation management is essential for reducing wildfire hazards, creating safer conditions for firefighters, and serving as a key climate adaptation strategy as climate change increases our wildfire risks.

As the Fire Prevention Branch Battalion Chief of the Hawaii Fire Department, I am in charge of the prevention of fires to include wildfires. Our main task is to preserve life and property. Overgrown and numerous fuels on the island of Hawaii are in abundance. When a wildfire starts on State Land (which is one of the largest landowners on Hawaii Island), numerous agencies and resources come together to mitigate or extinguish the fire. Sometimes, this can take days or weeks to extinguish which can be expensive. Unmanaged brush and vegetation that are in close proximity to homes increases the risk of wildland fire spreading and endangering communities, lives, and property. I'm sure there are other impacts such as endangering animals and the watershed. Reducing fuels is a major precaution to help protect the wildland urban interface

(WUI) area and also to help protect residents, visitors, and firefighters from the dangers of these wildfires.
