### TESTIMONY IN SUPPORT OF SB 440 - RELATING TO MEDICAL CANNABIS

Aloha, my name is DeVaughn Ward and I am the senior legislative counsel at the Marijuana Policy Project ("MPP") - the largest marijuana policy reform organization in the United States. As you may know, MPP has been working to improve marijuana policy for more than 25 years.

I am here today to testify in support of **SB 440– Relating to Medical Cannabis** 

MPP appreciates the opportunity to comment on SB 440. When the pandemic struck in the early days of 2020, many states declared cannabis businesses "essential" and adopt regulations to allow for patients to access their medicine in reduced contact or contactless ways through offering curbside or delivery options. Many states have since made these access points permanent recognizing the importance for patients, particularly those who are immunocompromised, to access their medicine through safe ways. SB 440 would allow the Department of Health to adopt rules to implement curbside pick-up for medical cannabis patients. This legislation would bring Hawaii into parity with other medical states that allow patients to access their medicine through curbside pick-up. We urge the committee to support SB440's passage.
