Chairs Wakai and Kim, Vice Chairs Elefante and Kidani, and Members of the Committee:

The Hawaii Correctional System Oversight Commission (HCSOC, the Commission) strongly **supports** Senate Bill 712, Relating to Adult Corrections Officers; UH; Windward Community College; and Trauma-informed Certification Program. This bill appropriates moneys to support a trauma-informed certification program for adult corrections officers at the Windward Community College campus of the University of Hawai'i.

According to the National Resource Center on Justice Involved Women (NRCJIW), one of the most common experiences shared by those who are incarcerated is a history of trauma. Research has shown that the effects of trauma can be significant and long lasting and are often times directly linked to the onset of substance abuse, mental health challenges, and criminal behavior. Experts recommend that all systems (medical, mental health, corrections, etc.) be trauma-informed and that professionals in these systems adopt universal precautions when working with individuals. Universal precautions require the assumption that a trauma history is present with all individuals interacted with, and to interact with them in a trauma-informed manner.

For some individuals, jails, prisons, and detention centers can further contribute to or be the source of trauma. The bright lights, loud noises, questioning by officers and staff, harsh physical handling/movement, restrictions, and sparse living quarters can be triggering. Triggers, if not handled appropriately, can result in assaults, suicide attempts, fights, and self-mutilation. According to the Substance Abuse and Mental Health Services Administration's National Center for Trauma-Informed Care and Alternatives to Seclusion and Restraint (NCTIC), Correctional facilitates can curb trauma-reactive symptoms within their populations with the following key components of trauma-informed care:

- Recognizing the impact of trauma on multiple areas of life and different paths to recovery.
- Being aware of the signs and symptoms of trauma.
- Structuring policies and practices that account for and are sensitive to people's potential trauma histories.
- Seeking to prevent re-traumatization

The Commission believes that encouraging officers to become trauma-informed will assist the officers in understanding an individual's history of trauma, understand their responses to trauma, and recognize the pathways survivors take in navigating safety and recovery. Taking these steps is imperative to having a therapeutic and rehabilitative corrections system. For these reasons, we support this bill.

- 2 potential for serious health problems and potential engagement in health-risk behaviors.

Adult Corrections Officers (ACOs) are exposed to working conditions that can have a negative impact on their health and safety. Providing support to ACOs should include education that focuses on wellness and resilience, and provide core knowledge about the impact of trauma on mental, physical and emotional health. This specialized training can help ACOs to better manage the challenges of their job.

8 WCC established the Mental Health Technician Certificate program in Spring 2022. This 9 program provides introductory training to those entering the mental health service field. 10 Courses in psychology, conflict resolution and mediation have provided 25 graduates with 11 essential skills that directly impact their ability to perform their jobs. Of these 25 graduates, 11 12 are employed at the Hawaii State Hospital.

We are very aware of the impact trauma has on individuals, families and communities and are ready and willing to support efforts to provide specialized training to ACOs, including those working at the Women's Community Correctional facility.

SB 712 - RELATING TO CORRECTIONS

Chairs Wakai and Kim, Vice Chairs Elefante and Kidani, and Members of the Committees:

The University of Hawai'i supports the intent of SB 712, which creates a Trauma Informed Care Course designed for Adult Corrections Officers (ACO's) taught by Windward Community College (WCC).

This coursework, deeper than a short training, is urgently needed. According to the Center for Disease Control, 97% of inmates have had at least one traumatic childhood experience. A large national study found that 40.1% of female inmates and 17.8% of male inmates suffer from Post Traumatic Stress Disorder (PTSD). Other studies have found 30% of male inmates have current PTSD symptoms and 60% have lifetime PTSD. Incarceration compounds potential trauma related issues, as it is an environment where the incarcerated feel a lack of personal control over situations and their own safety. Due to this, individuals may remain in a constant state high alert due to concern for personal safety and may be triggered by perceived threats and actions and/or interactions which remind them of past trauma. This can lead to inappropriate responses, including aggression, violence, anxiety, depression, and self-harm. Suicide is the leading cause of jail deaths nationwide. These impacts of trauma create a negative environment for the incarcerated individual, fellow prisoners, and the prison staff.

Trauma Informed coursework helps those serving incarcerated populations to better manage this population through understanding the impact of trauma. ACO's will be provided information on the lifelong effects or trauma, recovery needs, and implementation of trauma-focused treatment interventions, including evidence based best practice. Trauma triggers and examples of calming and grounding strategies will be discussed to help staff conduct their work more effectively and with less frustration. Vicarious trauma impacting correctional staff and suggestions for self-care will also be explored. Through this deeper exploration, those completing the coursework become best equipped to handle difficult situations that arise and support their coworkers. WCC is able to offer this course statewide both online and through a hub and spoke model in partnership with sister community colleges. The coursework can be completed in asynchronous, online classes, which can be taken at the employees' convenience and do not require a specific time in class or a specific location. Classes could also be offered in person at given facilities requesting this.

WCC has the expertise to offer this in collaboration with the Department of Public Safety (PSD). The program is based on our Mental Health Technician certificate developed in collaboration with the Hawai'i State Hospital and specific to the needs of workers and their context here in Hawai'i. WCC has been providing significant credit-based college education to incarcerated students since 2017.

This Trauma Informed Care Coursework positively impacts the prison environment for both workers and incarcerated individuals. This can have further positive impacts on retaining staffing due to decreased workplace frustration. This is important given the high turnover and staffing insufficiencies faced by PSD.

The University of Hawai'i supports the intent of SB 712, as long as its passage does not replace or adversely impact priorities as indicated in our BOR Approved Budget.

The United Public Workers, AFSCME Local 646, AFL-CIO ("UPW") **strongly supports** SB712, which appropriates moneys to support a trauma-informed certification program for adult corrections officers ("ACOs") at the Windward Community College campus of the University of Hawaii. This bill also requires the curriculum to include a Level I trauma-informed care course designed for ACOs.

As the exclusive bargaining representative for the correctional employees in Bargaining Unit 10, UPW recognizes that a significant proportion of the individuals in Hawaii's correctional facilities have experienced serious trauma during their lifetimes. The establishment of a Level 1 trauma-informed certification program would allow ACOs to better recognize the symptoms of trauma exhibited by inmates. Training in trauma-informed care could also be beneficial in allowing ACOs to recognize signs of work-related trauma displayed by their co-workers.

While we strongly support the proposed training offered to ACOs free of charge, UPW would like to note that there are challenges ACOs would need to overcome to access this certification program. Due to current staffing shortages and mandatory overtime, ACOs would likely be unable to regularly attend courses proposed in the bill without the support of and consideration from the Department of Public Safety.

STRONG SUPPORT SB712 RELATING TO CORRECTIONS.

Women's Prison Project strongly supports SB712 which would establish a basic trauma Informed care course designed for Adult Corrections officers and provided by Windward Community College (WCC). WCC has previously designed and successfully implemented a similar course for mental health workers at the Hawaii State Hospital.

The 2019 HCR 85 TASK FORCE report to the legislature addressed the need for trauma informed corrections staff, especially in the Women's Community Correctional System.

"Due to the high prevalence of trauma among incarcerated women, correctional staff need to be trained in and practice a high level of trauma-informed care (TIC). An environment that supports post traumatic growth provides important opportunities for positive change."

Research has consistently found that a high percentage of incarcerated persons have experienced extensive trauma, often since childhood. The prevalence of trauma, including sexual assault and abuse is particularly high among women. Traumatized individuals are often easily triggered by

interactions and procedures that raise feelings and memories associated with past trauma, especially in an environment where others have power and control over them. This can lead to aggression and resistance or to depression, anxiety and suicidality, affecting the safety of both staff and the inmates themselves.

It is now considered a standard best practice in settings working with vulnerable populations, to view persons and the impact of the environment, including the actions of personnel, through the lens of trauma. By understanding the impact of trauma and approaching interactions and procedures in a trauma informed manner, the rate of re-traumatization and the incidence of aggressive or self-harming behavior can be reduced. Trauma Informed environments and staff are more successful at rehabilitation. Incarcerated individuals who feel respected and emotionally safe act out less and are more open to learning new behaviors. Trauma Informed responses are important to reducing recidivism. Hawaii's recidivism rate is among the highest in the country. If Hawaii's corrections system is to move toward a more rehabilitative approach, trauma informed training of staff is necessary.

Women's Prison Project urges the legislature to pass SB712 and invest in a more effective corrections system by appropriating the funds to initiate this Trauma Informed Care Training for the Adult Corrections Officers who interact daily with the people in Hawaii's prisons.

STRONG SUPPORT FOR SB712 RELATING TO CORRECTIONS

Hawai'i Friends of Restorative Justice (HFRJ) strongly supports this measure appropriating funds necessary for Windward Community College (WCC) to create and provide a trauma informed certification program for adult correctional offices. I am Diana Bethel, Phd, coordinator for HFRJ's instructors who support peer tutors in HFRJ's higher and continuing education pilot project at WCCC.

HFRJ has studied best practices <u>for youth</u> since then. In 2004 HFRJ began studying and working with state adult prisons working to develop evidence based knowledge and what works to <u>decrease incarceration</u> and increase peaceful behavior. HFRJ's experiences working in the prisons and with youth, indicates that incarcerated people in Hawai'i suffer from a disproportionate share of <u>childhood abuse, neglect, and trauma</u>. This true for <u>other states</u> as well.

This bill would give WCC the means to create and provide "a level I trauma—informed certification program" for state adult correctional officers (ACOs). This would be for officers who *volunteer for the training.* While the state should require all ACOs to have knowledge about trauma informed care because most incarcerated people have experienced significant trauma, this program is for those ACOs who actively seek out more specialized training.

There are important differences in programs and learning when one is required to learn something compared to when one chose to learn something, and earn a certification based on their individual efforts.

A college certification is proposed here, which is different from mandating and requiring someone to learn something. This difference was discussed when continuing education was originally <u>suggested for nurses over 40 years ago</u>:

Requirements for voluntary continuing education pro- grams are higher than those required by most licensing boards to meet their mandatory requirements. This is

because it is a *recognition* program, and the recognition represents an achievement beyond the minimal requirements established by licensing boards.

The ACOs that chose to earn this trauma-informed certification would likely become assets to the department of public safety (PSD) in role modeling the value in learning this vital subject and they would provide real information to others who know only what PSD required them to learn. If PSD were most concerned with advancing trauma informed care in its institutions it would give the ACOs who earned this certification pay increases.

Hawai'i in general <u>lacks training</u> opportunities for corrections professionals and especially in trauma informed care, which is vital for assisting incarcerated people and for those who work with them.

Our state jails and prison are our <u>de facto mental institutions</u>. Corrections professionals need special skills to help the incarcerated. These skills can also help keep correctional staff and others safe while preforming their duties. STRONG SUPPORT SB712 RELATING TO CORRECTIONS.

Women's Prison Project strongly supports SB712 which would establish a basic trauma Informed care course designed for Adult Corrections officers and provided by Windward Community College (WCC). WCC has previously designed and successfully implemented a similar course for mental health workers at the Hawaii State Hospital.

The 2019 HCR 85 TASK FORCE report to the legislature addressed the need for trauma informed corrections staff, especially in the Women's Community Correctional System.

"Due to the high prevalence of trauma among incarcerated women, correctional staff need to be trained in and practice a high level of trauma-informed care (TIC). An environment that supports post traumatic growth provides important opportunities for positive change."

- Peer Support
- Collaboration and mutuality

- Culture, historical, and gender issues

Research has consistently found that a high percentage of incarcerated persons have experienced extensive trauma, often since childhood. The prevalence of trauma, including sexual assault and abuse is particularly high among women. Traumatized individuals are often easily triggered by interactions and procedures that raise feelings and memories associated with past trauma, especially in an environment where others have power and control over them. This can lead to aggression and resistance or to depression, anxiety and suicidality, affecting the safety of both staff and the inmates themselves.

It is now considered a standard best practice in settings working with vulnerable populations, to view persons and the impact of the environment, including the actions of personnel, through the lens of trauma. By understanding the impact of trauma and approaching interactions and procedures in a

trauma informed manner, the rate of re-traumatization and the incidence of aggressive or self harming behavior can be reduced. Trauma Informed environments and staff are more successful at rehabilitation. Incarcerated individuals who feel respected and emotionally safe act out less and are more open to learning new behaviors. Trauma Informed responses are important to reducing recidivism. Hawaii's recidivism rate is among the highest in the country. It is time to seriously

If Hawaii's correction system is to move toward a more rehabilitative approach, trauma informed training of staff is necessary.

Women's Prison Project urges the legislature pass SB712 and invest in a more effective corrections system by appropriating the funds to initiate this Trauma Informed Care Training for the Adult Corrections Officers who interact daily with the people in Hawaii's prisons.
