The Hawaii State Public Library System (HSPLS) supports the intent and provides comments on S.B. 752 S.D.1 which requires the Comptroller to identify state office buildings that can provide equitable telecommunication access to allow certain residents, including residents with disabilities, to participate remotely in legislative hearings. This measure also requires the Comptroller to submit a report of the findings and recommendations, including proposed legislation.

The HSPLS has been providing the public resources to participate in the legislative process for many years. In 2020, while most businesses and government offices were still closed to the public, the HSPLS deployed 16 Chromebooks and charging stations to all 51 public libraries statewide to supplement the technology already available at our public libraries. Working in coordination with both the Senate and House Clerk's Offices, we also updated our website and trained HSPLS staff in order to effectively assist any member of the public who wanted to participate in the 2021 Legislative Session. We look forward to working with the Comptroller to achieve the intent of this measure.

The Hawaii State Council on Developmental Disabilities **SUPPORTS SB752 SD1**, which requires the Comptroller to identify state office buildings that can provide equitable telecommunication access to allow certain residents, including residents with disabilities, to participate remotely in legislative hearings. Requires a report to the Legislature.

Remote testimony ensures greater accessibility, benefitting those that rely on others to travel. Members of the Intellectual/Developmental Disability (I/DD) community often rely on others for mobility, such as city bus systems or caregiver support. Chair Dela Cruz, Vice Chair Keith-Agaran and Members of the Committee, thank you for the opportunity to testify on S.B. 752, S.D. 1.

The Department of Accounting and General Services (DAGS) offers comments for S.B. 752, S.D. 1, which requires the Comptroller to identify state office buildings that can provide equitable telecommunication access to allow certain residents, including with disabilities, to participate remotely in legislative hearings and requires a report to the legislature.

We appreciate the intent of this measure and, based on our research and discussion with the Hawaii State Library System, we believe the infrastructure and resources may already be in place. The Hawaii State Library System currently has 51 libraries that have been outfitted with internet access (wifi), laptops, are environmentally

controlled (air conditioning), and have a staff capable of providing the necessary support to potential users wanting to access legislative hearings. The State's libraries are designed to support residents with disabilities to ensure access to the services available there. We will continue to work closely with the Hawaii State Library System to provide support and to help share information about the existing access.

Senate Bill 752 SD1 – Relating to Telecommunication

The Disability and Communication Access Board (DCAB) supports and offers comments on Senate Bill 752 SD1 – Relating to Telecommunication. This bill would require the Comptroller of the Department of Accounting and General Services to identify state office buildings that are able to provide equitable telecommunication access to allow residents of the Counties of Hawaii, Kauai, and Maui, and residents of rural areas in the City and County of Honolulu, including residents with disabilities, to participate remotely in legislative hearings. Also, this bill would require a report to the Legislature.

DCAB offers comments to ensure the report of findings and recommendations address compliance with Title II of the Americans with Disabilities Act, which requires state and local governments to ensure equal access for individuals who are disabled when providing programs, services, or activities, especially persons with communication access needs, that is, persons who are deaf, hard of hearing, or deaf-blind. As it concerns Senate Bill 752 SD1 and determining appropriate state office buildings where residents can remotely participate in legislative hearings, it is important to ensure that the identified buildings and programs are equally accessible to the full spectrum of persons with disabilities. These comments are offered to ensure that all individuals have equal opportunity to participate in processes of their government.
