IN SUPPORT of Senate Bill 770

Relating to Beach Park Restoration

Senate Bill 770 appropriates funds for a grant-in-aid to the County of Hawaii to hire an engineering firm to study, plan, assist and conduct preliminary design and concept work for a two-phase project to restore the Kahaluu Beach Park in the County of Hawaii. It conditions the appropriation on the County of Hawaiii contribution of matching funds.

The Hawaii State Aha Moku (Aha Moku) strongly supports this measure.

Added to the National Register of Historic Places on December 27, 1974, the Kahaluu District showcases Kahaluu Beach Park, a beautiful and popular beach that is a main attraction in Kailua-Kona, Moku O Keawe (Island of Hawai'i). It is heavily used by residents, native Hawaiian *lawaia* (fishing and gathering), tourists and visitors.

As is stated in SB 770, we believe that this two-phase project is necessary to preserve and protect this jewel of Hawai'i for current and future generations.

Historically, Kahalu'u is a sacred place to native Hawaiians. The area was once an important royal residence and was known for the *Pa O Ka Menehune*, a breakwater constructed in ancient Hawaii that might have once enclosed the entire bay. The *Ku'emanu Heiau* is on the north end of the bay and was used by royalty to view surfing. Two ancient *loko'ia* (fishponds) called *Waikua'ala* and *Po'o Hawai'i* are still visible. King David Kalakaua built a beach house in this area which has been reconstructed. South of the bay is *Hapaiali'i Heiau*, associated with astrological observation built between 1411 and 1465 and restored in 2007. These are just a few of the many historic places in the Kahaluu District.

Although Kahaluu Bay is better known for its snorkeling and ocean activities, the history of this special place is important to the native Hawaiian families of Kahalu'u and to Kailua-Kona. The restoration of the Kahaluu Beach Park is essential to the needed restoration of its true history. We support SB 770 and urge its adoption.

Honorable Chair Inouye, Honorable Vice Chair Elefante, and Members of the Committee on Water and Land, the Hawai'i County Department of Parks and Recreation submits the following in SUPPORT of SB 770.

This Bill appropriates funds for a grant-in-aid to the County of Hawaii to hire an engineering firm to study, plan, assist, and conduct preliminary design and concept work for a two-phase project to restore the Kahaluu Beach Park in the County of Hawaii. Conditions the appropriation on the County of Hawaii contribution of matching funds.

The Hawaii County Department of Parks and Recreation (hereinafter, "DPR") currently manages and has the maintenance responsibility for thirty beach parks in the County of Hawaii (hereinafter, "COH"). Kahalu'u Beach Park is the most visited beach park in the COH, and hosts upwards of four hundred thousand visitors annually.

Due to its low-lying state, Kahalu'u Beach Park must be frequently closed during high surf events and was the only COH Beach Park on Hawai'i Island that required closure for numerous days to conduct debris clean-up from the recent Tonga tsunami. This opportunity to hire an engineering firm to study, plan, assist, and conduct preliminary design and concept work for a two-phase project to restore Kahaluu Beach Park would help us work toward the restoration of a sacred place for future generations.

For the foregoing reasons, the Hawai'i County Department of Parks and Recreation SUPPORTS the passage of SB 770. Thank you for the opportunity to testify on this matter.

I am the director of the Kahalu'u Bay Education Center, a program of The Kohala Center (KBEC/TKC). KBEC collaborates with the County and the State of Hawai'i to revive and revitalize Kahalu'u Beach and Bay Park in Kona on Hawai'i Island. Kahalu'u Bay is a premier visitor destination and key Kona economic generator, a traditional community gathering place, and a coral reef spawning habitat. However, the bay and beach are threatened by both human interactions through trampling, waste disposal and by ocean acidification, sea level rise, ocean heating, and other climate change effects. In May 2022, Kahalu'u Bay was recognized by Dr. Sylvia Earle, world-renowned Marine Biologist, as the 141 Mission Blue Hope Spot. Hope Spots are **marine areas** that are considers scientifically critical to the ocean's health. Kahalu'u Bay on Hawai'i's West Coast Recognized as a Mission Blue Hope Spot - Mission Blue.

KBEC/TKC has taken a leadership role in the care of the Bay, offering a unique visitor experience that teaches respect for natural and cultural resources through education, public outreach, and research. We believe that to make wise conservation and development investment decisions, we need current information about the forces affecting the bay's marine structure, how those forces are affecting the terrestrial landscape now, and how they are likely to do so in the future. With good data and a carefully crafted master plan, existing educational and stewardship activities can be most effective while future developments to the park facilities and regulations about park and bay use can maximize the potential for conservation and restoration. It is in our best interest to mālama this precious wahi pana (sacred, cherished place) because this reef ecosystem is both a key spawning ground for marine life and a regional economic asset.

To sustain Kahalu'u Bay as a gathering place and marine resource for future generations and to implement and expand pono practices, a strategic preservation plan is critical. In September 2021, KBEC/TKC and Sea Engineering LLC completed a Kahalu'u Beach and Bay Coastal Hazard

Assessment Sea Level Rise (SLR) Report. This analysis considered how ocean trends affect the nearshore environment in the face of climate change. The report included recommendations for the restoration of the park. In December 2021, KBEC and Senator Kanuha's office formed a Kahalu'u Bay Working Group with members from State Planning, Army Corp of Engineers, County of Hawai'i Parks, and the Coastal Zone Management Program to work on the next steps for the restoration of the park. The group consensus was to apply for appropriate funding to begin the preliminary design and concept work.

We ask your **strong support for SB 770** to appropriate funds for the restoration of Kahalu'u Beach Park in the County of Hawai'i.

Aloha Chair Inouye, Vice Chair Elefante, and the Members of the Senate Committee on Water and Land,

I am writing as the president of Dear Ocean and a Mission Blue Hope Spot Champion for Kahalu'u Bay.

On May 26th, 2022, the international marine conservation nonprofit <u>Mission Blue named Kahalu'u</u> <u>Bay a Hope Spot</u>. It is the second designated Hope Spot in the state of Hawai'i, and a wahi pana—a sacred, celebrated, and storied place abundant with cultural and ecological treasures.

Dr. Sylvia Earle, Founder of Mission Blue, says, "Kahalu'u Bay serves as a model for other smaller bays around the world and shows how they too can harness the deep relationships between people and the environment to protect these cherished places. [the] Bay has become a beacon of hope and a source of inspiration for the community."

Kahalu'u Bay is now receiving international attention and will continue to gather more recognition as it matures into a Mission Blue Hope Spot model for other community stewardship programs worldwide. In fact, just this past June on World Ocean Day, the "Hope in Hawaii" webinar featuring Hawai'i's two Mission Blue Hope Spots aired with over one thousand individuals across the globe having registered to participate. How we choose to care for this ecologically important bay will have a wide-ranging and long-term impact.



Kahalu'u Bay is a treasure. The bay's coral reef is a key spawning ground for fish and coral, and acts as a nursery for juvenile fish and invertebrates including endemic and culturally significant species. The large, shallow, protected reef of Kahalu'u Bay is directly adjoined to a deeper offshore habitat making it an ideal location for spawning and dispersal to occur.

But, Kahalu'u Bay has seen profound changes in the past several decades. Overuse and development have severely degraded the reef in the bay, and coral deaths continue even in the absence of large-scale bleaching events. Local stressors include overcrowding and unsustainable tourism, sunscreen pollution, sediment kick-up, coral trampling, coastal inundation, sewage, and polluted groundwater runoff, as illustrated in the brief video Kahalu'u Bay | Then and Now. These stressors combine with warming waters to create synergistic negative impacts that further inundate the coastline and harm and kill marine life.

Clearly, much work needs to be done—before the damage is irreversible.
