The SFA appreciates the Legislature's continued support and commitment to creating new teacher housing for our educator workforce. We also appreciate that the Legislature has acknowledged that housing our educators has the dual opportunity of addressing our lack of affordable housing and our chronic teacher shortage in one project. We look forward to working with the Legislature, the DOE, and our State development partners to deliver teacher housing in the coming years.

The SFA, through partnership and collaboration with the DOE, have identified multiple sites that have preliminary been sited for teacher housing and are in areas that will serve multiple communities in need. These include Nanakuli High and Intermediate, Mililani and Waipahu High Schools. The SFA has the potential to engage with both public and private development partners for these types of projects in a variety of capacities.

The SFA would appreciate the consideration by the Legislature that there are critical issues that must be addressed when it comes to redevelopment and repurposing of existing school campuses. Depending on the expectations on the delivery date of these projects, the SFA may require additional considerations beyond funding to expedite these critical housing projects.

The SFA looks forward to continuing to work with the Legislature to deliver affordable housing for our educator workforce.
