Aloha Chair Todd, Vice Chair Kila, and members of the Committee on Transportation,

We appreciate the opportunity to provide testimony in **support** of SCR 170, which urges the Department of Transportation to establish a working group to evaluate options that provide additional air service to remote and underserved communities across the state.

The Hawai'i Tourism Authority's Destination Management Action Plans (DMAPs) were developed in collaboration with Hawai'i's communities. Contained in the Moloka'i DMAP is an action item to advocate "to restore affordable and dependable air and sea transportation to viable levels that meet the needs of the community." HTA has been in discussions with community members regarding the issues surrounding one airline operating to the island.

SCR 170 addresses the community's growing concern for stable and affordable air service. A working group is desperately needed to develop air service solutions for Moloka'i.
